# Natural Resource Inventory, presented by Ben Ganon

New Ulster County website that curates a collection of data sets. Main goal is to stream up-to-date data. Included in the NRI are water resources, land use, climate, cultural resources, story maps to help local laws, zoning and subdivision, and open space planning and protection. Close to 80 to 90 data sets. Print map function, as well. Still under development. ## SHV update

Started to delve in successful clean energy implementations. For example, there are 67 EV's and plugged in hybrids in Marbletown, as of 2022. SHV is also "polishing up" the clean power guide.

For next spring: the "coolest recycling drive": Hope to collect old refrigerators. Hudson Technologies will remove the refrigerants properly and recycle the metal. The metal can be sold, which should pay for the workers who handle the refrigerators. Need a place for Hudson Technologies to store items.

### **Action Grants**

Based on the number of air source heat pumps, the Town is line for a \$5000.00 grant from NYSERDA.

The Action Grant program continues for Marbletown. Starting June 1, the Town needs 10 new renewable heat installs for a \$10,000 grant; 15 gets \$20,000. Town is working on a way to directly access install data on building permit information. Installs include residential homes and businesses.

For solar (address, who, date) starting October 11: 10 installs earns \$5000, 50 is the next level. For EV's, starting October 11: 5 = \$5000, 15 = \$7500.

The grant money can be spent on anything that demonstrably reduces carbon emissions.

NOTE: Tom challenged folks at the November 30 meeting to come up with three best ideas on how to spend the money.

#### **Decarbonization Grant**

Judith Karpova will conduct an energy audit of the Marbletown Community Center. Engineering report on the MCC is also due soon. The information will be used to apply for a decarbonization grant from Partners for Climate Action. Wendy Saul, Tom, Alan, and Don LaFera are actively working on the grant, which has to be submitted November 21.

#### **Rate correction form Joule**

Marbletown's CCA bills were in error because everyone was on 100% NY renewable. Participants will get a refund. (Opt out of the CCA in Marbletown was 18%.)

### **RVHS** efforts

Club fair: 1 new member, possibly 2 more. Meet with UCRA to come in for an assembly to talk about composting. Met with other clubs to request help with recycling and sorting wastes; some clubs were interested. Met with Principal to ask for larger sorting facilities. Upcoming: meeting with new Director of Facilities.

## **Rondout Municipal Center**

Building manager instituted fees for EV charging. \$1 for plug-in and 18 cents/kW. Intent was to make the chargers profitable after annual fee for service and cost of electricity. Tom believes the \$1 plug in fee is problematic and will dissuade almost all charging; thereby, failing to raise significant revenue, keeping owners of PHEVs from plugging in, and increasing gas miles driven. He hopes to persuade the manager to drop the \$1 fee, and just go with a 15 or 20 cent per kWh charge. This should still be profitable and lead to significantly more charging.
