### **Group Purchase Update; other activities**

No update on group

Josh Cartwright [spelling?] of Sustaine.com approached Ben about proprietary software for small businesses that helps them use renewable energy and use energy efficiently. The company has a deal with Central Hudson. Even better, it is no cost to businesses. Their service

makes sense out of all the various programs available. Pass on to Rondout Valley Business Association, Ulster County and Better Business Bureau. County is trying to reignite a green business challenge. Ben will get back to Sustaine.

Association of Towns, which advises Town boards, has a service that helps residents understand electrical bills and makes sure that the billing is correct. Marbletown is looking into the service. This service can audit and interpret bills.

### **Opt-out solar**

Opt-out solar halted by PSC. Regulatory issues have held it up.

# **DEC Water Monitoring Program/Ashokan EIS**

Lots of submissions, still waiting to hear.

DEC has ordered NYC's DEP to revise the Ashokan Release EIS.

### **CEC** grants

No update on car purchase. Daisy will check on what is happening.

#### **New business**

**Discussion of potential new ECC members**: Lisa and Paris are interested in joining. Paris will send in an application.

**Opt-out solar should be coming this month**. Not applicable to anyone who already has signed up for solar or has solar arrays.

Daisy: NYSERDA has a new program to create building codes that outlaw fossil fuels. Money is available to implement it and that could be used to persuade Board Members. STRETCH is still not up and running in Marbletown and another, new program could be a "heavy lift" for the Town Board. Mabletown is in good position for this new program. Some concerns: Building department must be happy with another new program. People like gas stoves and eliminating them would raise opposition. And the Town is interested in affordable housing, which also may cause push back to new codes.

**Investment Committee:** Can't mention properties, but good presentations to Town Board. To fund the purchase of green space, the Town can pass a Community Preservation Tax. Money is a tax on the purchase of new homes. New Paltz has implement this tax. Could raise a lot of money.

**Lisa Giannco** is recommended unanimously for membership to ECC; her application will be forwarded to the Town Board.

Oliva asked: Given the recent, widespread outages across Marbletown, could Central Hudson underwrite a Tesla Power Wall? Green Mountain Energy in VT does it. Would need approval of

PSC. Needs to be part of the state plan. Recommended calling State Senator Michelle Hinchey. Board is also collecting information on the NY state plans to deal with this issue; best place to push the idea.
