Mr. Wood motioned to accept the July Planning Board Meeting Minutes as amended. Mr. Kostides seconded the motion.

## PB2019-02SBD - New Application

High Falls Central, LLC (Quinn)

2 Lot subdivision

107 Main Street, High Falls, NY 12440

Elizabeth Quinn, owner and her daughter Mia Quinn, were present on behalf of the application.

Zoning District: B-1, SBL: 70.46-2-3, Acreage: .52

Mrs. Quinn gave a quick recap of the application and what they were applying for.

Chairman Proctor stated that since the property is in the historic district the Board has to classify the action as a type 1 action and seek lead agency.

# Mr. Wood motioned to classify the application as a Type 1 under SEQR. Mr. Hansen seconded the motion.

# Mr. Wood motioned to seek Lead Agency and send out notice to all involved and interested agencies. Mr. Hansen seconded the motion.

Chairman Proctor explained the Lead Agency process to the applicants before he opened the meeting for public comment.

Philip Russak, a neighbor, stated that he didn't really have a concern with the application but was upset with the notification process. He felt that he should have received the notification earlier than the Saturday before the Monday Planning Board meeting. Shaye Davis, as Secretary, stated that the notice was sent by certified mail 5 days in advance of the Planning Board meeting. Mr. Russak stated that he was also upset with the fact that his name was spelled incorrectly. Ms. Davis stated that she had used the spelling of his name identified by the County.

Neighbor Jim Allred stated that same concern about the late delivery of the notification as Mr. Russak.

Chairman Proctor stated that the board would investigate and if deficiencies were identified in the notification process the board would correct them.

There were no more further questions from the public.

#### PB2019-02SPA - New Application

DiDonna Brothers, LLC – Ulster Saving's Bank James Reynolds, Architect Amendment to Site Plan Approval 2003 3857 Main Street, Stone Ridge, NY 12484

Zoning District: B-1 SBL: 69.2-5-3.200 Acreage: 6.25

James Reynolds, the architect for the project was present on behalf of the application.

Mr. Reynolds explained the Site Plan to the Board and what they would like to do. He stated that there's no change to the lighting, just new lighting on the porch. They're also getting rid of the parking spots in the front of the bank and leaving 1 for handicap parking. The board determined that there was sufficient parking available. Mr. Reynolds also indicated that the new plans showed an additional drive through teller to accommodate larger vehicles.

The Board discussed adding something to the side and front of the addition to make it look more fitting. They discussed options like a shadow box, bulletin board, window or landscaping. The Board requested the lighting schedule for the application.

Chairman Proctor suggested possible bike rakes in front of the bank.

Mr. Reynolds stated that they would have the existing Ulster Saving's Bank sign on the front of the addition and the hours of operation sign which they currently have as well. He added that Barry Medenbach from Medenbach and Eggers would be supplying a letter regarding the septic and stormwater but that he did not think there would be that much of a change.

Mr. wood motioned to classify the application as a Type II under SEQR. Mr. Cobb seconded the motion.

Mr. Wood motioned to refer the application to the Ulster County Planning Board and the local Fire Department. Mr. Kostides seconded the motion.
