## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that pursuant to Section 276 of the New York State Town Law, a public hearing will be held by the Marbletown Zoning Board of Appeals at 6:00 p.m. at the Rondout Municipal Center, Room M-1, located at 1915-1925 Lucas Avenue, Cottekill, New York on Wednesday August 25<sup>th</sup>, 2021, for the purpose of considering:

> 2021-05 AV: Variance for Required Yard Setbacks on Accessory Apartment Marcus Fox #12-14 Rybak Lane, Stone Ridge, NY, 12484 SBL: 62.3-4-4, R-3 Zoning, 2.7 +/- Acres. Proposes the conversion of an existing 580 sq. ft. barn, situated within the required yard setback, to be converted into conditioned habitable space for the purpose of establishing an Accessory Apartment. Per Town Code, a detached structure approved as an Accessory Apartment is required to meet the setbacks of the zoning district or be granted an Area Variance.
