






What do you think is the top preservation priority for Marbletown? 224 responses




What do you think is the second highest preservation priority for Marbletown? 224 responses





What do you think is the third highest preservation priority for Marbletown? 222 responses









Clean water and air and soil are priceless...and so is living in a community that values people and nature over profit...and one where natural beauty surrounds us and inspires us every day.

A. The survey is so fragmented that it is hard to imagine it producing useful information. There are few residents who would not appreciate progress in all of the resources described. Basically, they all boil down to discouraging development, which I and many others advocate.

- B. Supporting "conservation" through a dedicated tax source is bad policy. I am well acquainted with this sort of revenue stream from living in Manhattan for 30 years and observing the impact of flip taxes on transfers of shares in cooperative apartment buildings. This sort of tax or fee is applicated as being rather benign, being levied only upon those with a large amount of cash on their hands as a result of an asset that has appreciated substantially while in their ownership. (Whether paid by seller or buyer, this tax will reduce net compensation to seller). There are several flaws in this argument.
- 1. Residences in Marbletown have not always appreciated in value prior to sale. As I recall, after the great recession it took a decade before the local housing market returned to its level prior to the 2008-9 crash.
- 2. While most sellers will find themselves with an usually large amount of cash, at least for a moment, many of them will find themselves with a compelling need for all of it. For instance, those planning a move to a retirement community such as a CCRC, those moving to an larger residence for an expanding family and those looking to pay off an overextended mortgage will be counting every dollar.

3. Such taxes will effect availability of affordable housing in a negative manner.

All of the proposed uses for a preservation fund are activities for which local governments should be responsible, along with other services provided: highways, recreation facilities, first responders such as fire and ambulance services and recreation facilities. They should be supported by the same revenue stream, the general fund supported by the existing property tax and sales tax. These preservation activities will be for the benefit of all of the residents of Marbletown and they should be supported by the same tax base as the other services provided by the town. One could add rhetorical questions: Why should preservation be the only activity of local government which is supported by a dedicated tax on housing sales? And what will be the beneficiary of the next dedicated tax on housing sales?

Every time I see a new house being built and habitat being cleared, I think to myself, who does this actually benefit?

Historical regulations and preservation restrictions can be economically restrictive, benefiting only those who can afford the added costs. "scenic vistas", "scenic views," and "viewshed". Have you considered how this might skew results? Perhaps better minimize duplication and provide definitions of terms.
