INTRODUCTION

The Vly-Atwood District (FD 087) (“Fire District”) in the Town of Marbletown (“Town”) was established by resolution of the Town Board to provide a means to collect tax revenue to provide for fire and emergency services to the persons and properties within the Fire District. The Board of Fire Commissioners of the Fire District has always been and continues to be the “governing body” of the Fire District.

The fire and emergency services for all times relevant hereto have been provided to the Fire District by the Vly-Atwood Fire Co., Inc. (“Department”).

The tax ID Code “FD 087” for the Fire District appears on the final assessment rolls of the Ulster County Real Property Tax Services and is comprised of all of the taxable properties in the Fire District.

For a period of many months, the Department has been unable to provide sufficient personnel to the Fire District to provide an effective firefighting and emergency response agency. Given the reality that the Fire District is no longer able to provide the essential services for which it was created, the Fire District should be dissolved and the area served should be managed by the Town of Marbletown by the establishment of a fire protection district that will encompass the entirety of the existing Fire District. By following this plan of action, the immediate needs for the provision of fire protection for the properties within the former fire district will be met and the Town will have the sufficient time to develop a more comprehensive plan for future fire protection involving neighboring fire districts and fire companies.

Therefore, the Board of Fire Commissioners brings forth the within Governing Body Initiated Dissolution Plan to dissolve the Fire District to comply with the legal mandates in compliance with General Municipal Law Article 17-A.

**GOVERNING BODY INITIATED DISSOLUTION PLAN
PURSUANT TO
GENERAL MUNICIPAL LAW SECTION 774**

- (A) The name of entity to be dissolved is the Vly-Atwood District (FD 087), referred to herein as the “Fire District”.
- (B) The territorial boundaries of the Fire District exist as designated by the Town Board of the Town of Marbletown in establishing the Fire District. The boundaries are generally described as follows: Those parcels within the Town of Marbletown listed on the attached Schedule “A”.

A map showing the area comprising the Fire District is Annexed hereto as Schedule “B”.

- (C) The type of entity is a fire district as described in Town Law Article 11.
- (D) If uncontested, the cost of the dissolution is estimated to be less than \$10,000.00.
- (E) No public employees will be affected by the dissolution.
- (F) The Fire District owns the following assets:

Various firefighting equipment collectively estimated to be valued at \$ 15,000.

The Fire District has cash assets in the amount of \$246,762 in operating and capital reserve accounts.

The Fire District has a contingent account receivable of in the amount of \$59,780 from 2022 fire district tax levy receipts.

Total cash and non-cash assets amount to \$539,543

- (G) The Fire District has liabilities and/or indebtedness in the amount of \$15,364 consisting of:
- Ulster County Self-Insurance plan liability of \$15,364;

The Fire District does not have any bonded indebtedness and does not intend to incur any obligations prior to dissolution

The Fire District has a contingent liability relating to potential New York State Department of Labor fines and penalties that could amount to as much as \$178,997.

The Fire District does not own any real property. The Vly-Atwood Fire Station is owned by the Vly-Atwood Fire Co., inc. The expectation is that the fire station will be utilized in the future as a fire station-public safety facility and a public sheltering or meeting space. The expectation is the Vly-Atwood Fire Co., Inc. will convey or by other means transfer custody and control of the facility to a governmental or fire service entity for continued use for the benefit of the public.

- (H) The Fire District has not entered into any agreements with any other municipal entities.
- (I) The residents and businesses of the area included within the Fire District will continue to be provided fire and emergency services through and after the date of dissolution by neighboring fire departments pursuant to the Ulster County Office of Emergency Management's Mutual Aid Plan. In forthcoming years, the Town may establish a fire protection district to provide contractual service for the area
- (J) The terms for disposition of assets and liabilities are as follows:
 - (1) The assets will be transferred to the Town of Marbletown.
 - (2) All liabilities and indebtedness will be paid off by the expenditure of current assets or capital reserves where appropriate.. It is expressly provided that there shall be no further tax levies made by the Fire District.
- (K) No rule or regulation of the Fire District or Town is expected to be necessary or remain in effect after the dissolution occurs.
- (L) The effective date of the dissolution is June 30, 2022.
- (M) The date, time, and location of the statutorily required Public Hearing on the dissolution plan is Sunday June 26, 2022 commencing at 6:00 PM at the Vly-Atwood Fire Station 172 Vly-Atwood Road, Stone Ridge, New York 12484.
- (N) Miscellaneous Matters
 - (1) Prior to and upon dissolution, that the Fire District will undertake such actions as may be reasonable and prudent to preserve assets and to provide for the continued provision of fire to the area of the Fire District by means of mutual aid assistance only. The Fire District will not function as a firefighting or emergency services provider entity during the pendency of the dissolution. The Fire District will continue to function for administrative purposes only in order to wind up the affairs of the Fire District
 - (2) Fire protection will continue to be provided in the Fire District through at least June 30, 2022 under the current terms of the pre-existing mutual aid agreements.

- (3) The Marbletown Town Clerk in lieu of the Fire District Secretary and on behalf of the Board of Fire Commissioners shall cause this Plan of Dissolution to be published in accordance with General Municipal Law §775 and schedule a Public Hearing on behalf of the Fire District concerning the dissolution pursuant to General Municipal Law §776.

DESCRIPTIVE SUMMARY OF PLAN OF DISSOLUTION

The Vly-Atwood District (FD 087) Plan of Dissolution provides for the dissolution of the Fire District effective June 30, 2022. The provision of fire and emergency services will be unaffected and will continue to be provided to the area by neighboring fire departments pursuant to the Ulster County Office of Emergency Management's Mutual Aid Plan. All tax revenue previously collected by the Fire District, all capital reserve accounts, and all cash assets, will be remitted to the Town of Marbletown to be used for the continued provision of fire protection services through December 31, 2022 and beyond. Fire District property such as apparatus and equipment will be transferred to the Town of Marbletown with the express intention that those assets will be repurposed by other fire service agencies in the Town that will be providing fire protection and emergency services on a mutual aid basis to the properties that are located within the boundaries of the Fire District. The Fire District has no employees. Once the Fire District is dissolved, the Town of Marbletown will assume the responsibility for providing fire protection and fire suppression services to the area and will become the authority having jurisdiction over any fire protection district established in place of the Fire District. The Vly-Atwood Fire Co., Inc., though still technically an active corporation at the commencement of this dissolution process, will no longer provide any fire protection services to the Fire District or surrounding areas.

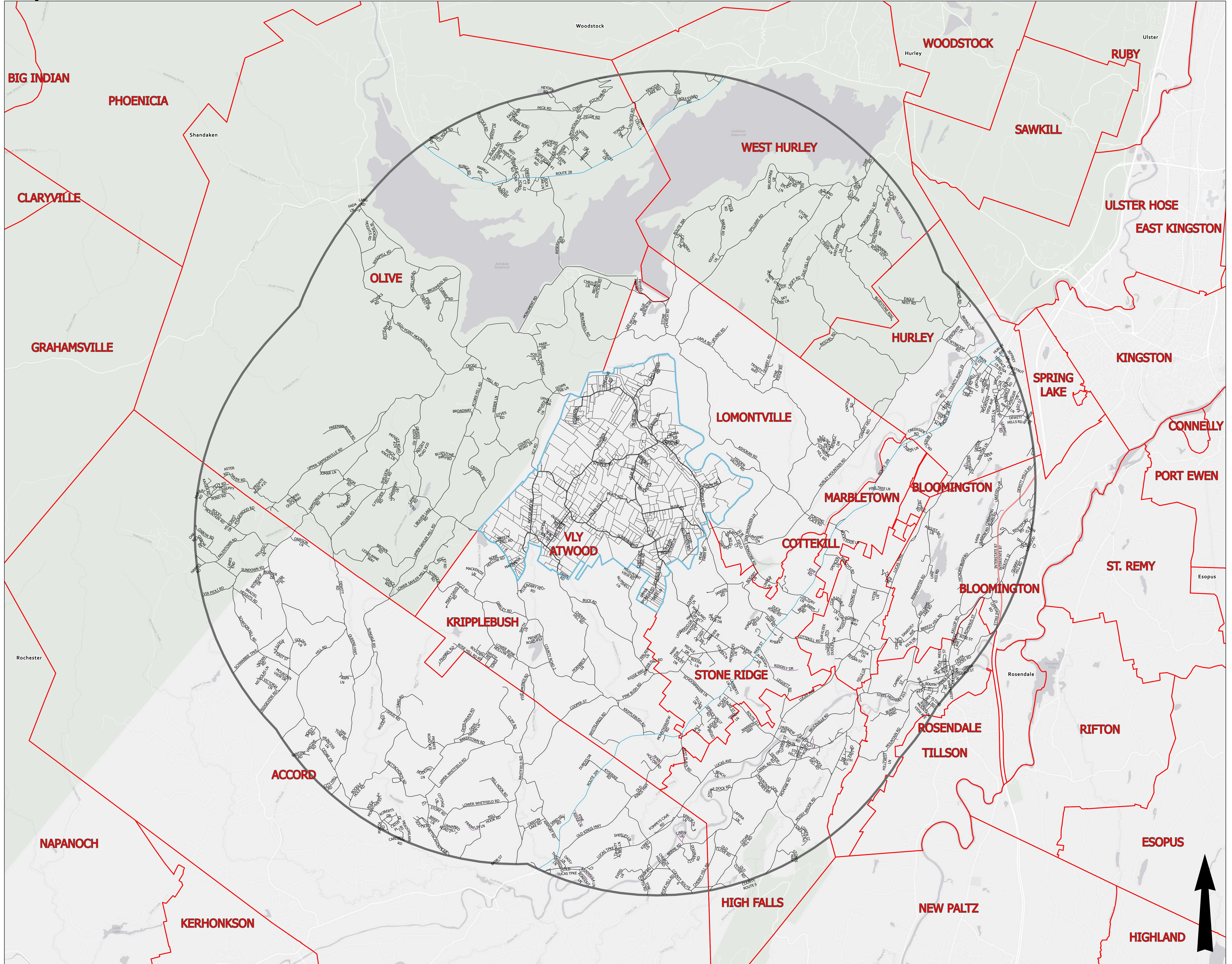
