WHEREAS, the Dog Warden will be paid a salary of Two Hundred Nine and 41/100 dollars (\$ 209.41) per week; and

WHEREAS, the Town of Marbletown will reimburse the Dog Warden and Deputy Dog Warden \$ .56 per mile for use; and

WHEREAS, the Town of Marbletown is responsible for a kennel and dog care; and

**NOW, THEREFORE, BE IT RESOLVED** the Town of Marbletown appoints Jill Shufeldt Dog Warden effective January 1, 2020 to December 31, 2021.
