A regular meeting of the Town Board of the Town of Marbletown was convened in a public session of the Town Hall, 1925 Lucas Ave Cottekill, New York on September 6, 2022, at 6:00 o'clock P.M. local time. RESOLUTION# 2022 ESTABLISHING A FIRE PROTECTION DISTRICT IN THE AREA OF THE FORMER VLY-ATWOOD FIRE DISTRICT

WHEREAS, Town Law §170 authorizes the town board of a town or the town boards of more than one town to establish in such towns a fire protection district for the purposes stated in such law provided all of the territory in such fire protection district shall be contiguous and shall be located outside of the boundaries of any incorporated village; and

WHEREAS, a Regular Meeting of the Town Board of the Town of Marbletown was duly scheduled, noticed, and conducted on August 16, 2022, for the purposes of, among other things, giving consideration the establishment of a fire protection district in the area of the town that formerly comprised the territory of the Vly-Atwood Fire District (FD 087) which is now dissolved pursuant to General Municipal Law Article 17-A; and

WHEREAS, at its Regular Meeting on August 16, 2022, the Town Board duly adopted by majority vote a resolution to consider establishing a fire protection district in the area of the town that formerly comprised the territory of the Vly-Atwood Fire District (FD 087) and to conduct a public hearing on the matter as required by law; and

WHEREAS, on September 6, 2022, the Town Board of the Town of Marbletown conducted a Public Hearing pursuant to Town Law §170 and §171 at the Marbletown Town Hall, 1925 Lucas Ave. Cottekill, NY 12419 to hear all persons interested in the proposed establishment of a fire protection district in the area of the town that formerly comprised the territory of the Vly-Atwood Fire District (FD 087).

NOW THEREFORE, BE IT RESOLVED, that the Town Board determines that all of the statutory prerequisites for publication and posting to provide notice of the Public Hearing and for conducting the Public Hearing were complied with in accordance with Town Law §171; and

BE IT FURTHER RESOLVED, that following the conclusion of the Public Hearing on the matter the Town Board of the Town of Marbletown proposes that the Town Board establish a fire protection district in the area of the town that formerly comprised the territory of the Vly-Atwood Fire District (FD 087) pursuant to Town Law §170; and

BE IT FURTHER RESOLVED, that the Town Board of Town of Marbletown Board determines that: (1) all those properties, property owners, and interested persons within the proposed fire protection district are benefitted by the establishment of said fire protection district; (2) all of the properties and property owners benefitted thereby are included within the boundaries of the proposed fire protection district; and (3) the establishment of a fire protection district in the area of the town that formerly comprised the territory of the Vly-Atwood Fire District (FD 087) is in the public interest.

BE IT FURTHER RESOLVED, that the Town Board of the Town of Marbletown hereby establishes Marbletown Fire Protection District No. 1 in the area of the town that formerly comprised the territory of the Vly-Atwood Fire District (FD 087), the boundaries of which are more specifically identified as the area delineated by the attached map and include all of the taxable parcels set forth in the attached schedule of properties identified as being located within said fire protection district; and

BE IT FURTHER RESOLVED that the Town Clerk is directed to record a certified copy of this Resolution with the County Clerk of the County of Ulster and to file a certified copy of this Resolution with the New York State Department of Audit and Control, Office of the State Comptroller within ten days of this date pursuant to Town Law §173.
