· Work proposed:

Replace the existing outdoor unit model AOU36RLXFZ1 S# LXN007575 with bad EEV assembly with an exact replacement outdoor unit model AOU36RLXFZ1. Placed on existing stand, reconnect all existing piping & wiring. Evacuate system and add additional R-410A refrigerant as required for proper charge, start up and check operation.

With this contract approved the fee from the 3 previous services (7/6/23-7/20/23 & 7/24/23) to diagnose the issues with this system will be dismissed.

Tax exempt status and prevailing wage labor rates have been used.

Not included:

Any repairs or replacement of indoor units and associated piping or wiring.
