SCHEDULE A PROPOSED TERRITORY OF THE MARBLETOWN FIRE DISTRICT

BOUNDARY DESCRIPTION

The following shall describe and constitute the northern boundary of the Marbletown Fire Protection District No. 2 as it meets the southern boundary of the Town of Hurley Fire District.

Starting at a point of the intersection of the northwestern corner of the Marbletown Fire Protection District No. 2, meeting the southern boundary of the Town of Hurley Fire District, being at the intersection of the northwest corner of tax parcel 55.3-2-30 and the intersection of such parcel with the southwest corner of tax map parcel 55.4-10-5 where both parcels intersect the Town of Hurley boundary line with the Town of Marbletown boundary line, being approximately geo-coordinates: 41.906880, -74.089765; and then

Running in a southeasterly direction along the northern boundary line of tax map parcel 55.3-2-30 to the intersection of the centerline of Creekside Road; and then,

Running in a northerly direction along the centerline of Creekside Road to the intersection of the border of the Town of Hurley at the northwest corner of tax parcel 55.3-2-32, and then,

Running in a southeasterly direction along the northern border of Tax Map Parcels 55.3-2-32 and 55.3-2-42, crossing State Route 209; and then,

Running in a southeasterly direction along the northern boundary of Tax Map Parcel 55.4-11-9.210, 55.4-11-9.220, 55.4-11-9.140, 55.4-11-9.130, 55.4-11-9.110, 55.4-11-18, and 55.4-11-10 to the northeast corner of Tax Map Parcel 55.4-11-10; and then,

Running in a southwestern direction along the eastern boundary of Tax Map Parcel 55.4-11-10 to the northwest point of Tax Map Parcel 55.4-11-15; and then,

Running in a southeasterly direction along the northern border of Tax Map Parcel 55.4-11-15 to the western border of the Town of Hurley, continuing along the southwest border of Tax Map parcel 55.4-11-14, further continuing to the northwest corner of Tax Map Parcel 55.4-9-27.

The following shall describe and constitute the eastern boundary of the Marbletown Fire Protection District No. 2 as it meets the southwestern boundary of the Town of Hurley Fire District and the northern and western boundaries of Cottekill Fire District.

Starting at a point of the intersection of the northeastern corner of the Marbletown Fire Protection District No. 2, meeting the southwestern boundary of the Town of Hurley Fire District, being at the intersection of the northeast corner of Tax Map Parcel 55.4-11-15 and the intersection of such parcel with the northwest corner of Tax Map Parcel 55.4-9-27 where both parcels intersect the Town of Hurley boundary line with the Town of Marbletown boundary line, being approximately geo-coordinates: 41.896946, -74.075548; and then

Running in a southwesterly and southerly direction along the western border of the Town of Hurley and along the eastern border of Tax Map Parcels 55.4-11-15, 55.4-11-16, and 55.4-11-17, before bearing southerly along the eastern border of Tax Map Parcel 55.4-11-17 and continuing to the intersection of the boundaries of the Town of Hurley and Town of Rosendale at the southwest point of Tax Map Parcel 55.4-9-29 where the western boundary of Cottekill Fire District begins; and then.

Running in a southwesterly direction along the southeastern border of Tax Map Parcel 55.4-11-17 to the northwest corner of Tax Map Parcel 62.2-1-6; and then,

Running in a northwesterly direction along the southern border of Tax Map Parcel 55.4-11-17 to

the western border of Tax Map Parcel 55.4-11-18; and then,

Running in a southwesterly direction along the western border Tax Map Parcel 55.4-11-18 to the northwestern corner of Tax Map Parcel 55.4-11-25; and then,

Running in a northwesterly direction along the southwest border of Tax Map Parcel 55.4-11-18 to the southeast corner of Tax Map Parcel 55.4-11-26; and then

Running in a southwesterly direction along the southwest border of Tax Map Parcel 62.1-4-26 to the northeast corner of Tax Map Parcel 62.1-4-25; and then,

Runing in a northwesterly direction along the southwestern border of Tax Map Parcel 62.1-4-26 to the western border of Tax Map Parcel 62.1-4-2; and then,

Running in a southwesterly direction along the southwestern border of Tax Map Parcel 62.1-4-2 to the northeast corner of Tax Map Parcel 62.1-4-4.110, where the northern border of Cottekill Fire District begins; and then,

Running in a northwesterly direction along the southwestern border of Tax Map Parcel 62.1-4-2 to the eastern border of Tax Map Parcel 62.1-4-1.100; and then,

Runing in a southwesterly direction along the southeastern border of Tax Map Parcel 62.1-4-1.100 to the northern border of Tax Map Parcel 62.1-4-4.110; and then,

Running in a northwesterly direction along the southern border of Tax Map Parcel 62.1-4-1.100 to the southwestern point of the same that intersects the northern border of Tax Map Parcel 62.1-4-1.110; and then,

Running in a northeasterly direction along the western border of Tax Map Parcel 62.1-4-1.100 to the northwestern point of Tax Map Parcel 62.1-4-4.110 that meets the southern border of Tax Map Parcel 62.1-4-1.100; and then,

Running in a northwesterly direction along the southern border of Tax Map Parcel 62.1-4-1.100 to the eastern border of Tax Map Parcel 62.1-3-26.181; and then,

Running in a southwesterly direction along the eastern borders of Tax Map Parcels 62.1-3-26.181 and 62.1-3-26.171 to the southeastern point of Tax Map Parcel 62.1-3-26.171; and then,

Running in a northwesterly direction along the southern borders of all Tax Map Parcels along the southern side of Rock Ledge Lane to the southwestern point of Tax Map Parcel 62.1-3-26.140, where the western border of Cottekill Fire District begins; and then,

Running in a southwesterly direction along the eastern borders Tax Map Parcels 62.1-3-19.100, 62.1-3-18, 62.1-2-21.100, and the eastern border of Tax Map Parcel 62.1-2-21.200 where it bears southeast to the northwest point of Tax Map Parcel 62.1-2-41.400; and then,

Running in a southeasterly direction along the northeastern borders of Tax Map Parcels 62.1-2-41.400, 62.1-2-41.300, and 62.1-2-41.200 to the northeastern point of Tax Map Parcel 62.1-2-41.200; and then,

Running in a southwesterly direction along the eastern borders of Tax Map Parcels 62.1-2-41.200 and 62.1-2-41.100 to the southeastern point of Tax Map Parcel 62.1-2-41.100, extending to the centerline of Marcott Road; and then,

Running in a northwesterly direction along the centerline of Marcott Road to the northeastern corner of Tax Map Parcel 62.1-2-38.100; and then,

Running in a southwesterly direction along the eastern border of Tax Map Parcels 62.1-2-38.100; and then,

Running in a southeasterly direction along the eastern border of Tax Map Parcel 62.1-2-33.700; and then,

Running in a southeasterly direction along the northeastern border of Tax Map Parcel 62.1-2-33.500 before bearing in a southwesterly direction along the eastern border of the same; and then,

Running in a southwesterly direction along the eastern boundary of Tax Map Parcel 62.1-2-9.300 to the southeastern point of the same that borders the western boundary of Tax Map Parcel 62.3-6-7.

The following shall describe and constitute the southern boundary of the Marbletown Fire Protection District No. 2 as it meets the northeastern boundary of Stone Ridge Fire District.

Starting at a point of the intersection of the southeastern corner of the Marbletown Fire Protection District No. 2, meeting the northeastern boundary of the Stone Ridge Fire District, being at the intersection of the southeast corner of Tax Map Parcel 62.1-2-9.300 and the intersection of such parcel with the northeast corner of Tax Map Parcel 62.3-2-12-211 being approximately geocoordinates: 41.864218, -74.116392; and then,

Running in a northwesterly direction along the southern border of Tax Map parcel 62.1-2-9.300 to the southeast point of Tax Map Parcel 62.3-2-12.212; and then,

Running in a northwesterly direction along the eastern border of Tax Map Parcel 62.3-2-12.212 to the northeast point of the same; and then,

Running in a northwesterly direction along the northern border of Tax Map Parcel 62.3-2-12.212 to the northwest point of the same; and then,

Running in a southwesterly direction along the western border of Tax Map Parcel 62.3-2-12.212, before bearing westerly and again southwesterly along the western border of the same to the southwest corner of the same; and then,

Running in a northwesterly direction along the southern border of Tax Map Parcel 62.1-2-9.300, before bearing northerly and northeasterly along the eastern border of Tax Map parcel 62.3-2-11 to the northeast corner of the same; and then,

Running in an easterly direction along the southern border of Tax Map Parcel 62.3-2-3 to the southeast point of the same; and then,

Running in a northerly direction along the eastern boundaries of Tax Map Parcels 62.3-2-3 and 62.3-2-28.100 to the northeast corner of Tax Map Parcel 62.3-2-28.100; and then,

Running in a northwesterly direction along the northern border of Tax Map Parcel 62.3-2-28.100 to the centerline of State Route 209; and then,

Running in a northerly direction along the centerline of State Route 209 to the southeast point of Tax Map Parcel 62.1-2-9.221; and then,

Running in a northwesterly direction along the southwestern border of Tax Map Parcel 62.1-2-9.221 to the southwest point of the same that meets the eastern border of Tax Map Parcel 62.1-2-9.130.

The following shall describe and constitute the western boundary of the Marbletown Fire Protection District No. 2 as it meets the northeastern boundary of Stone Ridge Fire District and the eastern boundary of Lomontville Fire District.

Starting at a point of the intersection of the southwestern corner of the Marbletown Fire Protectio, District No. 2, meeting the northeastern boundary of the Stone Ridge Fire District, being at the intersection of the southwest corner of Tax Map Parcel 62.1-2-9.221 and the intersection of such parcel with the northwestern corner of Tax Map Parcel 62.1-2-9.210 being approximately geocoordinates: 41.873552, -74.122349; and then,

Running in a northeasterly direction along the eastern border of Tax Map Parcel 62.1-2-9.130 to the northeast corner of the same that meets the border of Tax Map Parcel 62.1-3-16; and then, Running in a northwesterly direction along the northeastern border of Tax Map Parcel 62.1-2-

9.130 to the southwest point of Tax Map Parcel 62.1-3-16 within Esopus Creek, where the eastern border of Lomontville Fire District begins; and then,

Running in a northerly direction along the banks of Esopus Creek to Fording Place Road; and then, Crossing Fording Place Road and continuing in a northerly direction along the western boundary of Tax Map Parcels 62.1-3-12.200, 62.1-3-12.110, 62.1-3-12.120, and 62.1-3-11; and then,

Running in a northerly direction along the centerline of Esopus Creek, before bearing northeasterly along the same, and continuing along the same to the boundary of Tax Map Parcel 55.3-2-19.100; and then,

Running in a northeasterly direction along the western border of Tax Map Parcels 55.3-2-19.100 and 55.3-3-12, which follows Esopus Creek; and then,

Running in a northeasterly direction along the western border of Tax Map Parcel 55.3-3-8.100, before bearing easterly along the same, bearing northeasterly along the same, and then bearing northerly again, to the southwest point of Tax Map Parcel 55.3-3-9 that intersects the northwest point of Tax Map Parcel 55.3-3-8.100; and then,

Running in a northwesterly direction along the eastern boundary of Tax Map Parcel 55.3-2-18.111, before bearing northeasterly along the same, and then bearing northwesterly along the same, to the eastern boundary of Tax Map Parcel 55.3-2-22; and then,

Running in a northerly direction along the western border of Tax Map Parcel 55.3-2-21 to the northwest point of the same; and then,

Running in a southeasterly direction along the northern border of Tax Map Parcel 55.3-2-21, crossing State Route 209 to the western boundary of Tax Map Parcel 55.3-3-3; and then,

Running in a northeasterly direction, following State Route 209, along the western borders of Tax Map Parcels 55.3-3-3, 55.3-3-2, 55.3-3-3 again, 55.3-3-1, and 55.4-11-1 to the northwest corner of Tax Map Parcel 55.4-11-1; and then,

Running along the southwestern border of Tax Map Parcel 55.3-2-27, crossing State Route 209 and Creekside Road, and continuing along the southwestern border of Tax Map Parcel 55.3-2-27 to the southwest corner of the same; and then,

Running in a northeasterly direction along the western border of Tax Map Parcel 55.3-2-27, before bearing easterly along the same to the southwest point of Tax Map Parcel 55.3-2-28; and then,

Running in a northeasterly direction along the western boundaries of Tax Map Parcels 55.3-2-28, 55.3-2-29, and 55.3-2-30 to the northwest point of Tax Map Parcel 55.3-2-30 along the northern boundary of the Town of Marbletown and the southern boundary of the Town of Hurley.
