#### RESOLUTION #52-2021; CONTRACT WITH MARBLETOWN FIRST AID UNIT

The following Resolution was offered by Councilwoman Foote seconded by Councilman Stewart: **WHEREAS**, the Town of Marbletown desires to contract with Marbletown First Aid Unit (MFAU) for the provision of emergency and general ambulance services, Basic Life Support ("BLS"), and AdvancedLife Support ("ALS); and

**WHEREAS**, MFAU has represented to the Marbletown that it cannot provide the manner and level of ambulance service availability desired by the Town in the absenceof financial support in the form of a subsidy provided by the Town of Marbletown and revenue recovery by MFAU; and

**WHEREAS**, the Town of Marbletown intends to levy an ad-valorem-based tax upon the taxable properties located within Marbletown and/or draw from existing revenues orreserves to provide such subsidy for ambulance services; and

**WHEREAS**, the Town of Marbletown desires to establish a uniform contractual arrangement forthe provision of ambulance services with MFAU dependent upon MFAU complying with the terms of the AGREEMENT and pursuing revenue recovery for ambulance services provided within the Town of Marbletown from users of the ambulance service with the expectation that revenue gained through revenue recovery is be used to lessen the tax burden for Marbletown residents and further, to provide for the continuation and improvement of the provision of ambulance service within the Town of Marbletown by MFAU.

**NOW, THEREFORE, BE IT RESOLVED**, in consideration of the mutual promises recited herein and other good and valuable consideration, the receipt of which is hereby acknowledged, the Town of Marbletown does contract with MFAU to furnish ambulance services to said Town of Marbletown, and MFAU agrees to furnish such ambulance services, subject to the following provisions:

**BE IT FURTHER RESOLVED,** that the Town Board of the Town of Marbletown authorizes the Supervisor to sign said contract on behalf of the Town of Marbletown.

- Chuck Foster, MFAU president, and Joe Vitti, MFAU vice president, thanked the town board for the new arrangement and the extra funding.
- Supervisor Parete said the town would get the check with the additional funds ready next week. He said there will be further discussions later in the fall when the budget season started.

- Councilman Hunt pointed out that he appreciated the community meeting with the town board and MFAU.
- Supervisor Parete added that Councilwoman Foote and Councilman LaFera spent time with the rescue squads' leaders to come up with a plan that would benefit both the MFAU and the town. \$40,000 was budgeted for this year and the new agreement will increase to \$150,000 for 2021.

#### RESOLUTION#53-2021 STRETCH ENERGY CODE

The following Resolution was offered by Councilwoman Foote seconded by Councilman Hunt:

**WHEREAS**, to prevent a statewide patchwork of stricter energy codes, the New York State Energy Research and Development Authority (NYSERDA) developed the NYStretch Energy Code – 2020 (NYStretch);

WHEREAS, a stretch energy code is simply an energy code that is more stringent than the minimum base energy code that can be voluntarily adopted by local jurisdictions. NYStretch is a voluntary supplement to the 2020 Energy Conservation Construction Code of New York State (2020 ECCCNYS) improves its efficiency an average of ten to twelve percent (10-12 %) more efficient than the minimum requirements of the base energy code, the 2020 Energy Conservation Construction Code of New York State (2020 ECCCNYS);

**WHEREAS**, some New York State municipalities have adopted stricter energy standards to ensure reduced energy costs for its residents and businesses;

**WHEREAS**, under NY Energy Law § 11-109, the Town of Marbletown is authorized to adopt a local energy code more stringent that the 2020 ECCCNYS;

WHEREAS, the Town Board is considering amending provisions of the Town Code Chapter #99 to add provisions for a local energy code "NYStretch"; and

**WHEREAS**, a public hearing was held on May 18, 2021, at which time all persons either for or against said amendments were heard; and

WHEREAS, the Town Board is declared Lead Agency for the purposes of environmental review with respect to the proposed resolution, in accordance with Article 8 of the Environmental Conservation Law of the State of New York, and the regulations promulgated thereunder at 6 NYCRR 617 (collectively, "SEQRA"); and

**WHEREAS**, the Marbletown Town Board, as Lead Agency, has advised that the proposed action meets the criteria of a "Type II Action" under SEQRA; now, therefore, be it further

**RESOLVED**, that Local Law No. 4 of 2021 is hereby adopted as follows:

LOCAL LAW NO. 4 OF 2021

A LOCAL LAW amending provisions of the Town Code Chapter #99 to add provisions for a local energy code "NYStretch" of the Marbletown Code;

BE IT ENACTED by the Town Board of Marbletown as follows:

- Supervisor Parete pointed out that the public hearing from May 18<sup>th</sup> had been help open. Parete stated he spoke with Dave Allen, Code Enforcement Officer and Shawn Marks, Planning/Zoning office and they both feel the town is prepared for the new rules. The town has been talking about this for about two years and the ECC has done a good job.
- Councilman Hunt made a motion, seconded by Councilwoman Foote to add an effective date of October 1, 2021 for the law to go into effect. 5-0, motion carried. This extra time will help in educating vendors and contractors.

# RESOLUTION#54-2021; AUTHORIZING STATE AND MUNICIPAL FACILITIES PROPGRAM FOR CONSTRUCTION OF GRADY PARK

The following Resolution was offered by Councilwoman Foote seconded by Councilman Stewart:

WHEREAS, the Town of Marbletown received a \$125,000 grant from Assemblyman Kevin Cahill to improve parking, sidewalks and Grady Park in High Falls, and

WHEREAS, the Town Board has a ninety-nine (99) year lease for Grady Park and would like to improve the gateway to the Hamlet of High Falls, and

**NOW THEREFORE BE RESOLVED,** that the Town Board of the Town of Marbletown authorize the Supervisor and Deputy Supervisor to sign the attached agreement to begin the grant administration process.

- Supervisor Parete pointed out that Grady Park will have four phases of improvements. When the pandemic hit the grant for Grady Park had been put on hold. The town is not, and has not, committed to spending millions of dollars, as some residents have been led to believe, per a number of emails that Supervisor Parete and the other town board received.
- Councilwoman Foote stated there is lots of misunderstanding about the process and if anyone has any questions or concerns they should contact one of the town board members to discuss and get the correct information.
- The grant from Assemblyman Kevin Cahill's office is a reimbursable grant, not a matching grant.
- GPI (Greenman-Pedertsen Inc.) will provide the specs and they will go out to bid. The Town Board will review the bids, approve all contracts and proceed from there.
