<u>RESOLUTION #89-2021; REQUESTING SPEED LIMIT REDUCTION ON HURLEY MOUNTAIN</u> ROAD

The following Resolution was offered by Councilman Hunt, seconded by Councilman LaFera:

WHEREAS, the Town of Marbletown has received complaints about the speed limit on Hurley Mountain Road, and

WHEREAS, Hurley Mountain Road is frequented by bicyclists and runners, and

WHEREAS, the Town of Marbletown recommends that the Ulster County Department of Public Works reduce the speed limit on Hurley Mountain Road from the current 55 miles per hour to 45 miles per hour from the Town line to Tongore Road, and

THEREFORE, BE IT RESOLVED, the Marbletown Town Board requests the Ulster County department of Public Works have the New York State Department of Transportation conduct such study on Hurley Mountain Road, and

BE IT FURTHER RESOLVED, a copy of this resolution shall be sent to the New York State Department of Transportation, as well as form TE 9a, to the County Superintendent.

• The Town has received complaints about the amount of people speeding on Hurley Mountain Road. This resolution will be sent to the State DOT and ask them to conduct a study on Hurley Mountain Road to see if the speed limit can be lowered. This process could take 3-4 months.

RESOLUTION #90-2021; ACCEPTING A PROPOSED LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT FOR FISCAL YEAR 2022 PURSUANT TO GENERAL MUNICIPAL LAW §3-c FOR COMMENCEMENT OF THE LOCAL LAW ADOPTION PROCESS

The following Resolution was offered by Councilwoman Foote, seconded by Councilman Hunt: WHEREAS, the Town Board has determined that it may be necessary for the Town of Marbletown to exceed the limit on the amount of real property taxes that may be levied by the Town of Marbletown pursuant to General Municipal Law §3-c for fiscal year 2022; and

BE IT FURTHER RESOLVED, the Town Supervisor has prepared a proposed local law to override the tax levy limit for fiscal year 2022 pursuant to General Municipal Law §3-c, and the same has been reviewed and approved by the Town Board members.

NOW, THERFORE, BE IT RESOLVED, that the Town Board hereby accepts the proposed local law for the year 2021 entitled "Local Law to Override the Tax Levy Limit for Fiscal Year 2022 pursuant to General Municipal Law §3-c" for commencement of the local law adoption process; and

BE IT FURTHER RESOLVED, that the Town Board hereby schedules a public hearing on said local law to be held on October 19, 2021 at the Rondout Municipal Center, 1925 Lucas Ave Cottekill NY 12419 at 6:00 p.m. and that the public hearing be duly noticed by the Town Clerk as required by law.

• The 2022 budget indicates the Town possibly going over the tax levy limit. When this happens the town has to pass a Local Law which authorizes the Town Board to override the tax levy limit on the amount of property taxes that may be levied by the Town of Marbletown by the adoption of a local law.

2022 BUDGET:

- The 2022 tentative budget was presented for review. Supervisor Parete said the board will take the next couple of weeks to discuss the tentative budget. At the next meeting on 10/19 the board will discuss and vote on changes, which would be the preliminary budget and then the public hearing on the budget will be set.
- The 2022 tentative budget will be made available on the website or in the Town Clerk's office.
- The General side of the budget went down 1.99%. The Highway budget went up 1.89%. The High Falls Water District remains the same at 0%. The overall tax increase for 2022 is 10.5%
- Health insurance shows about a 1% increase. The Town has MVP right now, but we are also getting a quote from CDPH.
- Liability insurance has gone from \$95,000 to %115,000.
- We are approximately \$162,000 over what is allowed. If we were to take out the Ambulance District we would be at 0% increase.
- Councilman Stewart brought up the possibility of hiring a grounds keeper for the park. The town has run into some maintenance issues as the Highway Department is very busy and can not always get to the issues right away.
- \$450,000 went into savings last year.
- Last year no elected officials were given raises. All other employees did get a raise in 2021.
- Councilman Hunt requested looking into more ways to save in the budget, so the tax levy is not raised by 10%. He would also like more pressure on a county solution for the expense of the emergency ambulance service. *This amendment was added after 10/19/21 town board meeting.

OTHER TOWN BUSINESS:

- Jill McLean, Youth and Rec Director, provided an update:
 - Pickleball has a huge following and due to Covid they were unable to play in the gym. Highway has started on the new Pickleball court, (out by the playground) and will continue to work on this.
 - The park has been super busy. The baseball field is getting used quite a bit and they would like to make some improvements.
 - The pavilion books up quickly and it would be nice to consider a couple more to accommodate more events.
 - The Youth & Rec are actively trying to look into different programs to offer. Possibly wrestling.
 - They had a great 6-week Camp program this past summer.
 - The Virtual Running Program will be starting at the end of this week. A number of local businesses have donated prizes. Thanks to Ollie's, Big E's and Stewarts.
 - On Sunday 10/31/2021 from 3:00 5:00pm there will be Trunk or Treating at the park. Last years Trunk or Treat was a great success!
 - The park will be open all winter this year and families are happy to hear this.
- Councilman Stewart stated they have been working on the connector trail to the College.
- The Eagle Scouts will be setting up a bike repair station on the rail trail.
- Councilman LaFera inquired about the possibility of charging for the use of the park.
- Councilman Stewart stated they had a great event at the Ridgewell Gym with lots of electric vehicles on site.
- Councilwoman Foote mentioned that the Marbletown Preservation Investment Commission was meeting tonight, and they hope to provide a mission statement to the Town Board.

PUBLIC COMMENT

• Carol Laurito, resident, commented that in order for seniors to stay in their homes, that they love, the Town should consider a formula for tax grievance. She feels very strongly that there should be a better system for the elderly.
