# #53-2016; RESOLUTION SETTING THE PUBLIC HEARING DATE FOR THE PROPOSED LOCAL LAW NUMBER 1 OF 2017, CLASSIFYING THE ACTION PURSUANT TO SEQRA AND REQUESTING PROPER PUBLICATION

WHEREAS, the Town Board finds it to be in the best interests of the residents of the Town of Marbletown to adopt A local law to modify certain language in the Appendix A Design Guidelines for Business Districts located in Chapter 200: Zoning in order to change the order Sections A-f and subsequently add one new Section number, clarify certain requirements and correct some errors and to achieve the purposes and objectives set forth in the Local law.

NOW THEREFORE, BE IT RESOLVED as follows:

1. Proposed Local Law #1 of 2017 is hereby classified as an Unlisted Action under the State Environmental Quality Review Act

2. Having reviewed Parts 1, 2 and 3 of a Short Environmental Assessment Form, upon adoption of this resolution declares a 'Negative Declaration' in order and requires no further action under SEQRA.

3. A public hearing will be held by the Town Board on Tuesday, at 7:00 PM local time at the Rondout Municipal Center, 1915-1925 Lucas Avenue, Cottekill, NY, to hear all interested parties on the proposed Local Law #1 of 2017 entitled "A local law for amending the Zoning Law to revise provisions that have created difficulties of interpretation or implementation."

4. The Town Clerk is directed to advertise such public hearing in the official newspaper of said Town, on the website of said Town and is directed to refer the proposed local law to all municipalities adjacent to the Town and any other applicable entities as required.
