- Councilman Hunt said that he has been seeing obtrusive fences cropping up and these really tall fences are becoming an issue. He also asked what happens to existing fences? # RESOLUTION; #109-2021: APPROVING UNITED PUBLIC SERVICE EMPLOYEES' UNION CONTRACT WITH GENERAL BARGAINING UNIT

The following Resolution was offered by Councilman LaFera, seconded by Councilman Stewart:

**WHEREAS**, contract negotiations between the Town of Marbletown and the United Public Service Employees Union have been ongoing for employees in the Highway and General Units; and

WHEREAS, the Town of Marbletown and the United Public Service Employees Union have reached an understanding on the terms of the agreement with the General Unit contract and have recommended its adoption; and

**WHEREAS**, the Town Board of the Town of Marbletown has approved the new agreement which runs from January 1, 2022, through December 31, 2024; now

**THEREFORE, BE IT RESOLVED THAT** the Town of Marbletown hereby approves said attached three (3) year agreement commencing on January 1, 2022, through December 31, 2024 with the United Public Service Employees Union for the General bargaining units and authorizes the Town Supervisor and Deputy Supervisor to sign the contracts.

- Supervisor Parete thanked Councilman LaFera for all of his hard work on the union contract. It will be good to get the general contract folks up and running with the new contract. All employees will be getting \$1.35 raise and employees will be going from an hour lunch to a half hour lunch which will give the full-time employees 37 ½ hours vs. the 35 hours which we have been doing.
- Councilwoman Foote stated that she loves how hard all of the employees work and it is the employees that keep the town running.

### **OTHER TOWN BUSINESS:**

- Supervisor Parete announced that tonight would be Councilman Stewart's last meeting with the Town. Parete thanked Councilman Stewart for his service and all of his hard work over the past four years and presented him with a plaque. Councilman Stewart said he really enjoyed working with this town board and he will miss everyone. The town board wished him well with the County Legislature and looked forward to working with him.
- Superintendent Dimler thanked Councilman Stewart for his years on the town board and pointed out how responsive Stewart always was with emails and phone calls, and he will be missed.
- Superintendent Dimler gave a quick update on the highway department and thanked the Town Board for always being so supportive of the Highway Department.
  - The Highway department took care of a lot of tree issues this spring due to all the dead ash trees.
  - They are working on putting together a shared service with Rosendale for a bucket truck. Maybe purchase a truck together in January or February.
  - $\circ$  They chip sealed 8  $\frac{1}{2}$  miles of road this summer.
  - Assisted Rochester and Rosendale putting down black top.
  - Helped remove the old playground equipment from the RMC playground.
  - Completed the Pickleball court outside at the RMC.
  - Assisted in building the 30-car parking lot behind the Ridgewell Gym in Stone Ridge. The Village of New Paltz helped with this also, so thanks to them.
  - Completed rail trail connector.
- Councilman Stewart took a moment to thank George and the highway department for all the work they do on the O&W Rail trail.
- Councilman Hunt asked George what his vision of the highway garage was. Dimler replied that they are looking into putting it up on Peak Road where the shale bank is located, which the town owns the property.
- Councilman Stewart mentioned that Hurley is going to have to build a new garage too and should we look into doing a shared garage. Dimler said it would be too far away for both towns.
- Supervisor Parete shared that the building department had just given out the 451<sup>st</sup> building permit.
- Supervisor Parete said that the Town had been given 250 Covid test kits and there were still a few left in the Town Clerk's office.
- Supervisor Parete announced that there had been a water leak in High Falls this week. Terry Johnson was called, and he went and discovered that a pipe had broken, and it was taken care of right away.
- Supervisor Parete said that they have had a lot of interest in the Housing Advisory Commission. In January we will appoint the members.
- Councilman Hunt said that the Ethics Commission had met this past weekend and they were still working on the forms.
- Supervisor Parete stated that a recent letter to the editor, published in the Blue Stone Press, was not true and contained false information. No one has submitted any applications to have a marijuana store in the old Applestone building on Rt. 209. This could never happen at this property as any marijuana store has to be 500 feet from a school and 200 feet from a church and this property borders the High Meadow school.

### PUBLIC COMMENT

- Bill Terpening, resident, submitted a public comment to Town Clerk Moody, along with reading the comment out loud. The comment is on file in the Town Clerk's office. Mr. Terpening reiterated that there had been a violation of the Code of Ethics by Supervisor Parete. He has also reviewed the Code of Ethics and feels the code in no manner establishes nor requires that a member of the public, who submits a complaint to the Town Board must instead initiate such complaint with the Board of Ethics. Furthermore, the Code does not authorize the Board of Ethics to review such complaints. He feels that regarding the Board of Ethics review authority, consider the lack of any reference in the Code to complaints from the general public. He included ethics laws from neighboring towns. Mr. Terpening believes the Town Board has an obligation and duty to consider his complaint of alleged violation of the Code by the Supervisor and to take any appropriate action that may be called for. Mr. Terpening is asking the town board to determine whether Supervisor Parete's conduct, as set forth in his previously submitted complaint, was in violation of the Code of Ethics and, if in violation, to take appropriate action.
- Maggie Colan, resident, commented that she had just reviewed the proposed fence law and she would like to make sure that there be a requirement of small openings in certain fences to allow for small animals to get through.

<u>Motion to adjourn</u>: There being no further discussion Supervisor Parete made the motion to dismiss the meeting, seconded by Councilman Stewart; 5-0Aye; motion carried. The meeting adjourned at 7:20pm. Respectfully submitted, Heather Moody
