# PRESENTATION; MARBLETOWN FIRE & EMS OPERATIONS

• Paul Bishop, Project Director provided a slide show presentation of the Marbletown Fire and EMS Operations, "An evaluation of Existing Conditions and Opportunities for the Future" to the Town Board. Please contact the Town Clerk's office for a copy of the presentation or visit the town website.

- Mr. Bishop and Dave Riley, from CGR met with members of our fire districts from Cottekill, High Falls, Marbletown, Lomontville and Stone Ridge back in March and April.
- On October 28<sup>th</sup> there will be a meeting with CGR, town fire commissioners and EMS to discuss the steps moving forward.
- CGR strongly suggests our districts should combine which would provide savings to our residents. This would also eliminate up to 30% of older apparatus, reduce expenses, expand sharing and coordination.

# RESOLUTION #95-2021; A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT FOR FISCAL YEAR 2022

The following Resolution was offered by Councilman Stewart, seconded by Councilman LaFera: **WHEREAS**, on October 5, 2021 a resolution was duly adopted by the Town Board of the Town of Marbletown, New York authorizing a public hearing to be held by the Town Board on October 19, 2020, at 6:00 p.m. at the Rondout Municipal Center at 1925 Lucas Avenue, Cottekill, New York, to hear all interested parties on a proposed Local Law entitled "A Local Law to Override the Tax Levy Limit for Fiscal Year 2022", and **WHEREAS**, notice of the public hearing was duly advertised in the Kingston Daily Freeman, the official newspaper of said Town on October 10, 2021; and

**WHEREAS**, the public hearing was duly held on the 19th day of October 2021 at 6:00 p.m. at the Rondout Municipal Center at 1925 Lucas Avenue, Cottekill, New York, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and **WHEREAS**, the Town Board having determined that all parties entitled to notice have been duly given notice thereof; and

WHEREAS, pursuant to 6 NYCRR Part 617 of the implementing regulations pertaining to Article 8 State Environmental Quality Review Act (SEQRA) the Town Board hereby determines that adoption of this proposed Local Law is a Type II action which would not have a significant effect upon the environment; and

WHEREAS, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law, with the sole enactment that the proposed law to create a provision to override Chapter 97 (Part A) § 3-C s.5, Laws of New York 2011 concerning the Property Tax Cap of 2% which states: The Town Board is hereby authorized to override the Tax Levy Limit established pursuant to General Municipal Law Sec. 3-c, for Fiscal Year 2021, and to adopt a budget for Fiscal Year 2022 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Sec. 3-c. is enacted, so that the Town can pass its 2022 budget.

• Mohonk Mountain House is planning to have fireworks on new years eve. They will provide the Town with all the appropriate insurance paperwork and Town Clerk Moody will provide documents to the Code Enforcement Officer and the High Falls Fire Department.

#### **2022 BUDGET DISCUSSION:**

- Supervisor Parete said that changes can be made to the preliminary budget and once that has been agreed upon it becomes the final budget, which is the one that is filed with the County.
- Supervisor Parete added that Rosendale and Rochester are still considering if they will join the Ambulance District. If they do it could mean the cost for Marbletown would go down. If they do not join they will

- not be included, and the ambulance will not be allowed to service them. Councilman Stewart added this is why we need a county wide service.
- Councilman Hunt pointed out he would like the 'Contingency' line reduced by at least a third, right now it is budgeted at \$60,000. Supervisor Parete said could discuss further but if something happens during the year and they need that money it would be an issue.
  - \*7:17pm Councilman LaFera disconnected from the meeting due to internet issues.
- Councilwoman Foote added that we are competing with school taxes and the town has always been good
  with keeping expenses down and she does not want to whittle away areas where we could use the money.
- The closing on the school is coming up and the closing cost are approximately \$52,000.
- Councilman Hunt wants to add a maintenance line to the budget.
- Supervisor Parete said over the next 5-6 years the town will have to be creative on how the money gets spent. We will be looking into grants.
- Supervisor Parete hopes that by the next meeting the union contracts will be finalized, and we'll know if Rochester and Rosendale will be joining the ambulance district.

#### **OTHER TOWN BUSINESS:**

- Town Clerk Moody reminded everyone that Trunk or Treat will happen at the Marbletown Park on Halloween, October 31<sup>st</sup> from 3:00-5:00pm. If you would like to sign up please contact the Youth & Rec Department.
- Councilman Hunt said you could still sign up for the Running/Walking program. There are about 25 residents already working on their goals.
- The Highway Department has been busy working on the College trail connector and they have started on the Pickleball Court.
- Supervisor Parete announced that the town offices will be closed on Nov. 2<sup>nd</sup>, Election Day, but the Transfer Station would be open their normal hours.
- Councilman Hunt stated the Ethics Committee would be having their first meeting soon and they would be reviewing the financial disclosure forms.
- Councilman Stewart reminded everyone to check the ECC Facebook for upcoming events.

# **PUBLIC COMMENT**

- Laura Cunningham, resident, stated she was glad to hear the County is abandoning the idea of senior housing on Leggett Road.
- Carol Laurito, resident, asked how long would it take Stone Ridge Fire to get to the Vly? She also wanted to know how long it would take for Kripplebush to get to the Vly?

<u>Motion to adjourn:</u> There being no further discussion Supervisor Parete made the motion to adjourn the meeting, seconded by Councilman Stewart; 4-0Aye; (Councilman LaFera left meeting early due to internet issues) motion carried. The meeting adjourned at 7:48pm.
