RESOLUTION#29-2022; STANDARD WORKDAY FOR FULL TIME NON-HIGHWAY TOWN EMPLOYEES

RESOLUTION #30-2022; LOCAL LAW# 3 KNOWN AS ALLOWING MEMBERS OF THE TOWN BOARD TO PARTICIPATE IN TOWN BOARD MEETINGS VIA VIDEOCONFRENCE FROM LOCATIONS OUTSIDE TOWN OF MARBLETOWN BOUNDARY LINES

The following Resolution was offered by Councilman LaFera and seconded by Councilwoman Foote.

WHEREAS, the Town Board of the Town of Marbletown held a public hearing on February 15, 2022, on Local Law Number 3 of 2022, known as "Allowing members of the Town Board to participate in Town Board Meetings Via Videoconference from locations outside the Town of Marbletown," and

WHEREAS, a resolution was adopted by the Town Board of the Town of Marbletown on January 18, 2022, setting a public hearing to be held by said Town Board on February 15, 2022at 6:00 p.m. on Zoom, to hear all interested parties on the proposed local law; and

WHEREAS, said public hearing was duly held on February 15, 2022, at said time and place and all parties were permitted an opportunity to speak on behalf of or in opposition to said proposed local law, or any part thereof; and **RESOLVED**, said Local Law is hereby adopted as attached

RESOLUTION #31-2022; PARKINSON'S AWARENESS MONTH

The following Resolution was offered by Councilwoman Foote and seconded by Councilman LaFera.

WHEREAS, Parkinson's disease is a progressive neurological movement disorder of the central nervous system, which has a unique impact on each patient; and

WHEREAS, according to the Parkinson's Action Network, the Parkinson's Disease Foundation, the American Parkinson's Disease Association and the National Institutes of Health, there are over one million Americans diagnosed with Parkinson's disease; and

WHEREAS, symptoms include slowness, tremor, difficulty with balance and speaking, rigidity, cognitive and memory problems; and

WHEREAS, although new medicines and therapies may enhance life for some time for people with Parkinson's, more work is needed for a cure; and

WHEREAS, increased education and research are needed to help find more effective treatments with fewer side effects and ultimately a cure for Parkinson's disease; and

WHEREAS, a multidisciplinary approach to Parkinson's disease care includes local wellness, support, and caregiver groups; and

WHEREAS, April has been proclaimed as Worldwide Parkinson's Awareness Month for all to recognize the need for more research and help in dealing with the devastating effects of Parkinson's disease.

NOW, THEREFORE, We, The Town Board, of the Town of Marbletown, do hereby proclaim April as Parkinson's Awareness Month in The Town of Marbletown

• Supervisor Parete said that we have been supporting April as Parkinson's Awareness month for many years now. This will help promote organizations that raise money and offer services for people and families impacted by the disease.

OTHER TOWN BUSINESS:

- Supervisor Parete commented on the recent increase in Central Hudson's electric rates and that lots of people are paying quite a bit more right now. Central Hudson announced the rate is gong to be 22 cents per kilowatt hour which is about 3 ½ times higher than Marbletown's preferred rates. The towns default electricity supplier is Community Choice Aggregation through Hudson Valley Community Power which is 100% renewable. The town locked in a 3-year rate at approximately 6.5 cents per kilowatt. The CCA is allowing residents to 'opt in' during the year at any point.
- Councilwoman Foote stated the last Planning Board meeting had gone well and the gentlemen that is opening the new hotel, across from Lydia's, had a lot of questions. Councilman Hunt asked what the time frame for the new hotel looked like. Foote responded that it was along way from being done.
- The proposed sign law is being worked on and hopefully something will be presented to the town board in the next 3 or 4 months.
- Councilman Hunt stated that the Ethics board would be meeting the following evening. The Ethics board continues to wait for guidance from the town Attorney. Hopefully, the forms will be distributed for review soon.
- Supervisor Parete hopes that we will be back in person for the next town board meeting on March 1st but he will watch the Covid numbers and make an announcement as the meeting gets closer.

EXECUTIVE SESSION:

- At 6:37pm Supervisor Parete made a motion to open an executive session, seconded by Councilman Hunt. 5-0; motion passed.
- The Town Board motions to enter into executive session for the purpose of
 - o Discussion of matters of acquisition or investment of real property.

- No votes were taken during executive session.
- At 7:52pm Councilwoman Foote made a motion to close the executive session and reconvene the meeting with no action taken nor monies expended, seconded by Councilman LaFera. 5-0; motion passed.
