RESOLUTION#51-2022 SOLAR GENERATION PROJECTS, LLC DECOMMISSIONING BOND

The following Resolution was offered by Councilman Davenport and seconded by Councilman LaFera **WHEREAS**, the **Solar Generation Projects, LLC** and **Town of Marbletown** have entered into an agreement whereby principal agrees to complete decommissioning in accordance with the Town of Marbletown Planning Board Approved a Resolution, which said agreement, dated 4/11/2021, is hereby referred to and made a part hereof; and Whereas, said Principal is required under the terms of said agreement to furnish a bond for the faithful performance of said agreement; and

WHEREAS, New York Solar DG 1 LLC, LLC, as Principal, and Arch Insurance Company, a corporation duly authorized under the laws of the State of Connecticut, as Surety, are held and firmly bound unto the TOWN OF MARBLETOWN as Obligee in the full and just sum of thirty-three thousand and eight hundred sixty dollars (\$33,860), lawful money of the United States of America, to be paid to the said Obligee, successors or assigns; for which payment, well and truly to be made, we bind ourselves, our heirs, executors, successors, administrators and assigns, jointly and severally, firmly by these presents.

NOW THEREFORE, the Town Board of the Town of Marbletown authorizes the Town Supervisor to accept said bond and to cause his signature to be made to formalize this acceptance

WHEREAS, Brinn Dimler is a current member of the Board of Ethics and has expressed an interest in continuing to serve, and

NOW THEREFORE BE RESOLVED, that the Town Board of the Town of Marbletown reappoint Brinn Dimler to the Board of Ethics for a term that ends 12/31/2026.

RESOLUTION #53-2022 APPROVAL OF COLLEGE CONNECTOR TRAIL AND PUBLIC PARKING SIGNS

The survey was sent out via email to those that have signed up for our town alerts. The link to the survey can also be found on the town website and social media accounts. As of Sunday, eighty-nine people had filled out the survey.
- Councilman Hunt also stated that there would be a special information meeting on 5/24, via Zoom to talk about the preservation plan. More details will follow.
- Supervisor Parete stated that there was going to be a Vly Atwood Firehouse meeting soon to work on a dissolution plan.
- Supervisor Parete reminded everyone that the Memorial Day parade will take place on Monday May 30th. This year the parade route will start at the Stone Ridge Town Centre with a 10:00am start.
