

Town Board Regular Meeting Tuesday, October 18, 2022 This regular meeting was held in person and began at 6:00pm

CALL TO ORDER

Supervisor Parete called the meeting to order at 6:02pm and Councilman LaFera lead the Pledge of Allegiance.

PUBLIC COMMENT

- Scott Albright, High Falls resident, suggested the Town consider the idea of a skating rink in High Falls in the space that they hold the flea market. Mr. Albright thought having a skating rink would help bring some life into High Falls during the winter. He mentioned in Gardner they put one in, and it was successful. Mr. Albright has offered to spearhead the project. Supervisor Parete added he thought it was a good idea and he'll discuss further with the Town Board.
- Bill Terpening, Stone Ridge resident, pointed out that the Ethics law was not posted, with changes, on the website.

PUBLIC HEARING & PRESENTATION; HISTORIC DESIGNATION OF 74 RIDGELY DRIVE:

- At 6:08pm a motion was made by Councilman Davenport seconded by Councilman Hunt to open the public hearing on the proposed Local Law # of 2022 'A Local Law on the Application for Proposed Landmark Designation of The Inn aka The Shawangunk Inn, part of former estate of Francis H. Leggett Ridgely Park, 74 Ridgely Drive", 5-0 Aye, motion carried.
- Supervisor Parete stated Town Clerk Moody had legally noticed the public hearing in the Daily Freeman on August 30th. The legal notice as also posted on the town website and the Town Clerk's Community Board
- Laura Cunningham, owner, and applicant, for the request of a landmark designation of her property at 74 Ridgely Drive, Stone Ridge, NY provided a slide presentation of the history of the property also known as The Inn aka The Shawangunk Inn, part of former estate of Francis H. Leggett, "Ridgely Park". Ms. Cunningham has lived on this property for 41 years. The Cunningham property was formerly a central part of the Leggett estate. Prior to Francis H. Leggett acquiring the building with 12.17 acres, to add to his property, this was the Shawnagunk Inn or known simply as The Inn and before that a "select boarding house." The Inn is a sprawling (4200 square feet approximately) Colonial style house, with

wraparound porches, set on 12.17 acres in the heart of Stone Ridge, accessed by Leggett Road and Ridgely Drive Private road which is an original carriage drive known as The Avenue (circa 1892). The home has been added onto in the 1890's and two existing houses were combined in 1849, to enable access to connect the rooms of the Inn upstairs and downstairs. The smaller house called The Innlet, predated The Inn, and was listed on the census in 1810 and has three bedrooms, two bathrooms, a parlor and butler's pantry. The main house (The Inn) has 5 bedrooms, 4 bathrooms, a living room and open kitchen/dining room. There has been few changes since 1892, and there are stone walls, a carriage step, a cistern, and a rustic tennis court set into the ruin of an old dairy barn which burned down in early 1900's. Ms. Cunningham also added that significant people that have visited the property are Francis H. Leggett, Swami Vivekananda, and Lord David Margesson. The Swami Vivekandanda is recorded in several books as having visited the Inn and given it a special blessing.

- Bill Terpening, town resident, said he thinks it all sounds great.
- Anthony DiGuiseppe, resident and former Historic Preservation Commission member, stated that it is important for people to lead by example and Laura had done a great job on her research and presentation and she be commended.
- At 6:20pm there being no further comments or questions on the proposed Local Law Councilman LaFera made a motion, seconded by Councilman Davenport to close the public hearing on the proposed local law, 5-0 Aye, motion carried. The board thanked Laura once again for all of her work on this project.

RESOLUTION#101-2022: AUTHORIZING AN AMENDMENT TO CHAPTER 128 HERITAGE PRESERVATION ADOPTED BY THE TOWN AS LOCAL LAW #1 -2007 AMMENDING APENDIX A DESIGNATION OF AN IDENTIFIED TOWN HISTORIC STRUCTURE

The following Resolution was offered by Councilman LaFera and seconded by Councilman Hunt: **WHEREAS**, a resolution was duly adopted by the Town Board of the Town of Marbletown for a public hearing to be held by said Town Board on October 18, 2022 at 6:00 o'clock P.M. local time, by the Marbletown Town Board at 1925 Lucas Avenue, Cottekill NY 12419 to hear all interested parties on a proposed local law entitled "A LOCAL LAW AMENDING APENDIX "A" OF CHAPTER 128 "HERITAGE PRESERVATION" OF THE TOWN OF MARBLETOWN CODE BY ADDING "The Inn" 74 Ridgley Drive; and

WHEREAS, notice of said public hearing was duly advertised in the Daily Freeman, the official newspaper of said Town, on October 8, 2022; and

WHEREAS, said public hearing was duly held on October 18, 2022. at 6:00 o'clock P.M local time, at the Rondout Municipal Center, 1925 Lucas Ave. Cottekill NY 12419 and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed local law, or any part thereof; and

WHEREAS, the Town Board has circulated said amendment of the local law to the Ulster County Planning Board; and

WHEREAS, the Town Historic Preservation Commission pursuant to the Marbletown Code Chapter 128 has recommended the designation of the property as a landmark and the Town Board may make such designation if such property

- 1. Possesses special character or historic or aesthetic interest or value as part of the cultural, political, economic, or social history of the locality, region, state or nation; or
- 2. Is identified with historic personages; or
- 3. Embodies the distinguishing characteristics of an architectural style for landmark characteristics eligibility; or
- 4. Is the work of a designer whose work has significantly influenced an age; or
 - a. Embodies a unique location or singular physical characteristic, represents an established and familiar visual feature of the neighborhood; or
- b. Is listed on the State and/or National Registers of Historic Places, or which is the subject of a pending application for listing, where such property meets one or more of the criteria of this section; and WHEREAS, the Marbletown Historic Preservation Commission recommended the designation of "The Inn" at 74 Ridgley Drive, Stone Ridge, NY 12484 as a landmark based upon their finding of facts, and

WHEREAS, the Town Board has considered the Historic Preservation Commission's recommendation and findings, as well as any comments made during the Public Hearing, and the criteria concerning such designation as set forth in the Heritage Preservation Law and agrees that "The Inn" should be designated as a local landmark based on Criterion B (as noted in #2 above) and the properties association with lives of persons significant to our past identified as Francis H. Leggett, Swami Vivekananda, and Lord David Margesson; and

WHEREAS, the Town Board, after due deliberation, finds it in the best interest of the Town of Marbletown to adopt the amendment to Appendix A of said Local Law;

NOW, THEREFORE, BE IT RESOLVED as follows:

- The Town Board of the Town of Marbletown hereby amends Chapter 128 "Heritage Preservation" of the Marbletown Code by adopting said Local Law No.8 of 2022 entitled "A LOCAL LAW AMENDING APPENDIX "A" OF CHAPTER 128 "HERITAGE PRESERVATION" OF THE TOWN OF MARBLETOWN CODE BY ADDING 74 RIDGLEY DRIVE, STONE RIDGE, NY 12484 AS A DESIGNATED LANDMARK."
- The Town Clerk is hereby directed to enter said Local Law in the minutes of this meeting and in the Local Law book of the Town of Marbletown, and to give due notice of the adoption of said Local Law to the Secretary of the State of New York.

WHEREAS, pursuant to 6 NYCRR Part 617 of the implementing regulations pertaining to Article 8 State Environmental Quality Review Act (SEQRA) the Town Board hereby determines that adoption of this proposed Local Law is a Type II action which would not have a significant effect upon the environment; and WHEREAS, That Local Law No. of 2022 Local Law Overriding Tax Levy Limit for 2023 is hereby adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes the Marbletown

WHEREAS, a resolution was adopted by the Town Board of the Town of Marbletown on September 6, 2022, setting a public hearing to be held by said Town Board on September 20, 2022 at 6:05 p.m. at the Rondout Municipal Center, to hear all interested parties on the proposed local law; and

WHEREAS, notice of said public hearing was duly advertised in the Daily Freeman, the official newspaper of said Town, not less than ten days prior to the date of said public hearing; and

WHEREAS, said public hearing was duly held on September 20, 2022 at said time and place and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed local law, or any part thereof; and

WHEREAS, at said public hearing comments were made and the Town Board has considered these suggested comments and has made minor inconsequential changes; and

WHEREAS, the proposed local law constitutes a Type I action for purposes of the State Environmental Quality Review Act; and

WHEREAS, the Town Board of the Town of has determined after review that the adoption of a Local Law known as the Code of Ethics Law does not have a significant environmental impact; and

WHEREAS, The Town Board of the Town of Marbletown after review finds that it is in the public interest to enact this local law.

NOW THEREFORE BE IT RESOLVED, by the Town Board of the Town of Marbletown as follows:

- 1. The Town Board hereby adopts said Local Law No. of 2022, entitled, "Code of Ethics Law".
- 2. The Town Clerk is hereby directed to enter said local law in the minutes of this meeting and to give due notice of the adoption of said local law to the Secretary of State of New York, and to take all other actions as may be required by law.

Supervisor Parete pointed out that the funding would have to be approved by a majority of the town board members. Councilman LaFera made a motion to amend #103; Section 24-8 to include 'funding to be approved by town board', seconded by Councilman Hunt, 5-0 aye, motion carried.
- Attorney Kellogg would like to have a definition of 'Conflict of the Management Plan' included. Councilman Hunt made a motion to include a definition of Conflict of the Management Plant, seconded by Councilman LaFera, 5-0 aye, motion carried.
- Attorney Kellogg will clean up the law and provide the final copy to Town Clerk Moody.

- Supervisor Parete said Ted Fink had been the planner in Warwick for 31 years and he will be assisting in analyzing the towns zoning codes and to clarify and make them easier to read and to follow.
- Councilman Davenport stated that he had reviewed Mr. Fink's background and it looks like he'll be able to detangle the redundancies from the town codes.
- Councilman LaFera added that he is excited about this, and he actually thought it would be more expensive.

OTHER TOWN BUSINESS:

- Supervisor Parete reported that changes can be made to the budget and at the next meeting, which is also the public hearing, final changes will be made after that. Town Clerk Moody added that the County has asked to have the preliminary budget forwarded on to them so they can get started on their process and once the final budget is approved that is sent by November 20th. Parete added that he hoped to have all the final insurance numbers to include in the budget in the next couple of weeks.
