

Town Board Regular Meeting Tuesday, November 1, 2022 This regular meeting was held in person and began at 6:00pm

CALL TO ORDER

Supervisor Parete called the meeting to order at 6:00pm and Councilwoman Foote lead the Pledge of Allegiance.

PUBLIC HEARING 2023 GENERAL, HIGHWAY & SPECIAL DISTRICTS BUDGET:

- At 6:02pm a motion was made by Councilman LaFera seconded by Councilman Davenport to open the public hearing on the proposed 2023 General, Highway and Special Districts Budget, 5-0 Aye, motion carried.
- Supervisor Parete stated Town Clerk Moody had legally noticed the public hearing in the Daily Freeman on October 23rd. The legal notice as also posted on the town website and the Town Clerk's Community Board.
- Bill Terpening, resident, read a prepared statement and submitted same with Town Clerk Moody on his comments on the 2023 budget with some comparisons to the 2022 budget. Mr. Terpening suggested adding a column to the budget to show percent increase/decrease of expenses from the previous year. He also suggested increasing the total of the appropriated surpluses or using some of the Covid Relief Fund to help reduce the increase in our property taxes. A copy of the statement will be on file with the minutes in the Town Clerk's Office.
- At 6:06pm there being no further comments or questions on the proposed 2023 General, Highway & Special Districts Budget Councilman LaFera made a motion, seconded by Councilman Hunt to close the public hearing on the 2023 budget, 5-0 Aye, motion carried.

PUBLIC HEARING 2023 HIGH FALLS WATER DISTRICT BUDGET:

- Councilman Hunt asked what the building line was for? Supervisor Parete responded that will be the maintenance person for the trails, mowing, etc. Councilman Davenport added we really need this person.
- Councilman Hunt asked about page 5-line A8010.1? Supervisor Parete responded that is the line for Shawn Marks who works ¼ of the time as the Planning Secretary, ¼ of the time as the Zoning Secretary and ½ the time in the Building department.
- Supervisor Parete explained that engineering costs are going down as there not as many projects going on right now.
- Councilman Davenport asked about the fire district budgets. Town Clerk Moody stated she would scan and email all the fire district budgets to the town board.
- Supervisor Parete said salaries are up and a lot of the staff need to be recognized for their work.
- Councilman Davenport mentioned that when people talk about taxes being high it is actually the school taxes that are taking all the money, not the town.
- Councilman Hunt added that liked Mr. Terpening's ideas on how to be transparent and have a comparison column.
- Councilman LaFera added he feels citizens get a bargain in this Town with all the volunteers that do not get paid. Parete added our volunteers are amazing.
- Councilwoman Foote said she would like to use the Covid Relief money to soften the blow *(lower taxes)* and Parete reminded her we are not allowed to use that money to offset tax levy. Councilman Hunt added he would like to be proactive with our *(planning for)* Covid money.

• Supervisor Parete stated that our current building manager had taken another job elsewhere. We advertised and interviewed a couple of candidates. Joe LaFera will be a Rosendale employee and Marbletown will pay 50% of his salary. Supervisor Parete mentioned that Councilman LaFera and Joe are cousins, but there is no conflict. For this reason, Councilman LaFera will abstain from voting.

OTHER TOWN BUSINESS:

- Supervisor Parete reminded everyone the town offices would be closed on Tuesday November 8th for Election day and Friday November 11th for Veteran's Day.
- Supervisor Parete announced that at the next meeting, Nov. 15th would be the public hearing for the dissolution of the Marbletown fire district which would follow the public hearing that the Marbletown Fire District would be having on the same day.
- Councilman Hunt asked about the quotes that had been submitted for the new heating system for the Community Center. Councilman LaFera said he would follow up and maybe they should consider doing mini splits at the Community Center.
- Councilman Hunt said the town park will be closing for the winter on 11/15 and we reopen again on 4/1/23. The new shed is in place and looks good. Winter LaFinca will not be happening at the park this winter.
- Supervisor Parete announced, again, that the Ethics Board is still looking for one more volunteer and the Housing Commission is looking for volunteers.
- Town Clerk Moody said that Trunk or Treat was a great success! Councilwoman Foote added that maybe next year we could do a parade.

PUBLIC COMMENT

• Bill Terpening, resident, read and submitted a public comment regarding the Town Board's adoption of the Code of Ethic's at the 10/18/22 meeting. Mr. Terpening listed numerous changes that were added to the draft. Terpening added a public hearing is lawfully required to be held on the final form of the Code of Ethics. Additionally, the version of the Code of Ethics was not given beforehand to the Town Board members for the required minimum number of days as required in Municipal Home Rule Law. Mr. Terpening's statement is on file in the Town Clerk's office and is part of the minutes.
