# PUBLIC HEARING ON A PROPOSED LOCAL LAW TO AMEND CHAPTER 172 "TAXATION" ARTICLE I; SENIOR CITIZENS TAX EXEMPTION OF THE TOWN OF MARBLETOWN TOWN CODE

- At 6:11pm a motion was made by Councilman Hunt, seconded by Councilman LaFera to open the public hearing on a proposed local law to amend Chapter 172 "Taxation" Article I; Senior Citizens Tax Exemption of the Town of Marbletown Code, 4-0 Aye, 1 absent motion carried.
- Supervisor Parete stated Town Clerk Moody had legally noticed the public hearing in the Daily Freeman on Saturday November 26, 2023. The legal notice as also posted on the town website and the Town Clerk's Community Board.
- Vivi Hlavsa, resident, stated she had sent an email to the town board, and she had received a response. Hlavsa asked who is getting the profit from this? Hlavsa added she knows a lot of people that moved out of NY because of taxes. Adding any reduction will be harder on single woman as they do not make as much as men. When the powers that be decided to turn this over to the local people they did not have rural New York in mind. Hlavsa pleaded to the board not to make a decision today, but to let more people speak up.
- Bill Terpening, read and submitted a prepared statement. Terpening also sent the town board a detailed analysis of why the new Option to include IRA distributions as income under the Senior Exemption is wrong since it results in egregiously inequitable treatment between the two main types of IRAs: Roth IRAs and traditional IRA's. Following are some of the arguments that I made to Board members: The word "distribution" can be misleading regarding IRAs. "Distribution" can imply earnings received on investments - dividends, capital gains, interest. However, IRA distributions are not distributions of earnings. They are simply withdrawals of money – the same as withdrawals from regular savings or checking account in a bank. Consequently, I use the word "withdrawals" to avoid such confusion. Income is misused under the Senior Exemption if applied to IRA withdrawals. These are the same as withdrawals from regular savings or checking account in a bank. Withdrawals whether from an IRA or a bank, are not income. Instead, only the earnings and interest are properly considered as income. This Option's essential fault is difficult to discern if one is not aware of the above-mentioned terms' usage and of specific details that apply to the two main types of IRAs. Income under the Senior Exemption is based on Federal Adjusted Gross Income (FAGI). For Roth IRAs qualified withdrawals are not considered as income in FAGI nor under the Senior Exemption nor under this new Option. ["Qualified withdrawals" simply means that a person is over 95.5 years old and has had their Roth IRA for at least five years.] For traditional IRAs, withdrawals are considered as income in FAGI – but solely because income taxes were originally deferred when deposits were made. Presently, under the Senior Exemption these withdrawals are rightly not considered as income. But under this Option, withdrawals from traditional IRAs are wrongly considered as income. This extremely inequitable treatment of traditional IRA withdrawals compared to Roth IRA withdrawals is blatantly wrong. Consequently, this Option wrongly singles out and causes undue distress and harm to some of our low-income seniors. If this ill-wrought Option is ill-advised adopted by the Board, the gods will bless those seniors with Roth IRAs and will damn those seniors with traditional IRAs.
- Laura Cunningham, resident, would like to commend the Board when they passed the maximum exemption for Seniors a few months ago. Please have empathy for those in the area, the elderly poor, please don't take more.

**WHEREAS**, the TOWN levied an ad-valorem-based tax upon the taxable properties located within the TOWN and/or draw from existing revenues or provide such subsidy for ambulance services; and

WHEREAS, the TOWN desires to establish a uniform contractual arrangement for the provision of ambulance services with MFAU dependent upon MFAU complying with the terms of the AGREEMENT and pursuing revenue recovery for ambulances provided within the TOWN from users of the ambulance service with the expectation that revenue gained through revenue recovery is be used to lessen the tax burden for TOWN residents and further, to provide for the continuation and improvement of the provision of ambulance service within the TOWN by MFAU, and

**RESOLVED**, in consideration of the mutual promises recited herein and other good and valuable consideration, the receipt of which is hereby acknowledged, the TOWN does contract with MFAU to furnish ambulance services to said TOWN, and MFAU agrees to furnish such ambulance services, subject to the following provisions: and **FURTHER RESOLVED**, the Town Board of the Town of Marbletown authorizes the Supervisor to sign the attached contract.

• Supervisor Parete said he had a class to attend on Tuesday, January 2<sup>nd</sup> so he was rescheduling to January 4<sup>th</sup>.

#### **OTHER BUSINESS:**

- Tom Konrad, ECC Chairman, announced that the town had qualified for a no-match \$5,000 grant through NYSERDA's Clean Energy Communities program. This "Action Grant" is the result of our efforts promoting the installation of heat pumps and heat pump water heaters in the community and can be used for a number of possible projects that will reduce Marbletown's dependency on fossil fuels. There are a number of other, similar action grants the Town hopes to earn by reporting the installation of more heat pumps, heat pump or hybrid water heaters, purchases of electric vehicles and sign ups for community solar. Konrad added to qualify we need the help of Marbletown residents and businesses, by taking part in the energy transition of fossil fuels. Konrad reminded everyone that he does free coaching sessions to educate you about what incentives might be available for you or your home. Anyone that helps quality for the grant can vote on how to spend the grant and the options that are being considered are: renovations at the Community Center, installing Electric Vehicle Chargers at the Town Park or working with the Marbletown Highway Dept to buy them electrified equipment.
- Supervisor Parete announced that the Light Up Parade would be Saturday, Dec. 16<sup>th</sup>.
- Town Clerk Moody mentioned that the High Falls Christmas Tree Lighting would be this upcoming Saturday the 9<sup>th</sup>. Councilman LaFera added that the High Falls Fire House would be taking toy and food donations on Saturday the 10<sup>th</sup>.

<u>Motion to adjourn:</u> There being no further discussion Councilman LaFera made the motion to adjourn the meeting, seconded by Councilman Hunt 4-0 Aye, 1 absent; motion carried. The meeting adjourned at 7:17pm.
