

Town Board Regular Meeting February 6, 2018 This regular meeting was held at the Rondout Municipal Center and began at 7:07pm

Supervisor Parete called the meeting to order at 7:01 pm and asked Councilman LaFera to lead the Pledge of Allegiance.

MEETING MINUTES:

LIASON REPORTS:

TOWN CLERK/TAX COLLECTOR (Town Clerk Moody):

• Working on collecting taxes. Due to the amount of 2017 pre-payments there will be more refunds this year. Most banks do not pay the taxes that they collect through escrows until Jan. 31st which means they are now trying to pay on taxes that have already been paid. We will now how to refund these banks and they will have to work it out with the residents.

ECC (Tom Konrad, ECC Chair):

- Still working on streetlights and discussing with Central Hudson about refunding the town.
- Continue working on the retrofit at the Community Center.

OTHER TOWN BUSINESS (Supervisor Parete):

- The town has open vacancies for an alternate on the Planning Board, a volunteer on the ECC and a volunteer on the Historic Preservation Comm. These vacancies are on the kiosk and the website, along with a volunteer form that can be filled out sent to supervisor@marbletown.net.
- Supervisor Parete is hiring a student from the ARC two afternoons a month to assist with making copies and getting ready for the town board meetings. He will reach out to the other departments to see if there are other tasks that can be given to her. Supervisor Parete will bring her around and introduce her to the other employees.
- Supervisor Parete is working on an Inter Connect agreement with a Solar Farm that we will enter into a PILOT (payment in lieu of taxes) program and this should be going out by the end of the week.

• Supervisor Parete is looking at Barton & Loguidice, an engineering firm to help with grant writing.

<u>Motion to adjourn:</u> There being no further discussion Councilman LaFera made the motion to adjourn the meeting, seconded by Councilman Stewart; 5-0 Aye, motion carried. The meeting adjourned at 7:22pm.
