RESOLUTION #39-2018; HEALTH INSURANCE BENEFITS FOR RONDOUT MUNICIPAL CENTER BUILDING MANAGER

The following Resolution was offered by Councilman LaFera seconded by Councilman Stewart to wit:

WHEREAS, the Town of Marbletown and the Town of Rosendale are parties to an Inter-Municipal Agreement dated December 9, 2015, which agreement sets forth the cooperative arrangement under which the Towns shall use, maintain and operate the Rondout Municipal Center; and

WHEREAS, Item 6 of said agreement discusses the position of Building Manager and the Towns respective contributions toward the salary and benefits for said position; and

WHEREAS, Steven Christiana is currently serving in the position of Building Manager and is an employee of the Town of Rosendale in accordance with applicable provisions of the Inter-Municipal Agreement; and **WHEREAS**, the Town of Marbletown and the Town of Rosendale have determined to offer health insurance to the incumbent Building Manager, Steven Christiana, in accordance with certain terms and conditions.

NOW, THEREFORE, BE IT RESOLVED, that so long as the incumbent Building Manager, Steven Christiana, continues to work in that capacity for at least twenty-five (25) hours per week, as well as for the Town of Marbletown as Fire Marshal for seventeen and one half (17.5) hours per week, the Town of Rosendale shall offer Mr. Christiana single health insurance coverage under the Town of Rosendale's plan, with Mr. Christiana contributing twenty-five percent (25%) toward the applicable health insurance premium; and

BE IT FURTHER RESOLVED, that the cost allocation of Mr. Christiana's health insurance shall be seventy percent (70%) for the Town of Marbletown and thirty percent (30%) for the Town of Rosendale, payable as mutually agreed by the two Towns; and

BE IT FURTHER RESOLVED, that should Steven Christiana fail to continue to work at least twenty-five (25) hours per week as Building Manager and/or fail to continue to work at least seventeen and one-half (17.5) hours per week for the Town of Marbletown as Fire Marshal, that the Town of Rosendale may discontinue offering individual health insurance to Steven Christiana and offer him coverage pursuant to COBRA in the alternative; and

BE IT FURTHER RESOLVED, that this Resolution shall become effective if approved by the Town Boards of the Town of Rosendale and the Town of Marbletown and shall remain in effect unless and until modified by future action of the Town Boards of the Town of Rosendale and the Town of Marbletown.

FACILITIES STUDY:

• Scott Davis from Peak Engineering submitted a proposal for engineering services related to the evaluations of Town owned buildings for the development of a long-term maintenance plan. Supervisor Parete will get a status update on this from Mr. Davis.

Councilman Sweeney excused himself from the meeting at 7:40pm.

LIASON REPORTS:

HIGHWAY (Superintendent Dimler):

- The highway sold some surplus equipment which is what the budget modification, page 2 of minutes, indicates.
- Superintendent Dimler provided the town board with the Agreement to Spend Highway Funds, pursuant to the provision of Section 284 of the Highway Law, the Town of Marbletown agrees that the money levied and collected for the repair and improvement of highways, and received from the state for the repair and improvement of highways shall be expended as follows:

Blacktopping approximately 5.6 miles totaling \$338,450.

Chip Sealing approximately 4.6 miles totaling \$64,495.

A motion was made by Councilman Stewart and seconded by Supervisor Parete to accept the Section 284 of the Highway Law and forward on to Tom Jackson at the County. 4-0; 1 absent; motion carried.

- Paving, with the help of Rosendale, will begin in June.
- Fixing the pot holes has been the priority the past couple of weeks.
- The highway has received a check from FEMA, from last year's blizzard, totaling approximately \$23,335. They have also received approximately \$190,000 from CHIPS, \$43,000 from Pave NY and \$36,500 from a severe winter recovery account.

JUSTICE (Councilman Borzumato):

• Justice Court report was provided.

ECC (Councilman Stewart & Tom Konrad):

- There is an issue with the DOT regarding the piece of land between Berme Road and Rt. 213 so they will be holding off on the pollinator garden until they proper permits are obtained. Residents, along with the High Falls Civic Association, will still be gathering on 4/21 from 10:00am 1:00pm to weed and get the land cleaned up for the garden.
- Letters were sent out to certain residents asking their opinion on specific street lights in town.
- There was discussion about having the town board meeting on May 15th starting at 5:30pm to give residents a chance to discuss the specific streets lights.

YOUTH AND RECREATION (Director Jill McLean):

- Director McLean welcomed Jessica Phelan who will begin work as the Assistant Recreation Director in May.
- The annual Easter Egg Hunt was held on Fri. March 30th. Approximately 70 children with their families attended on the rainy grey day. The Cider donuts were donated by Davenport's Farm Stand, so a big thank you to Davenport's for supporting the community for this event.
- A new split rail fence will be installed by the highway department at the park.

- Summer camp registration is going on now. There are 6, one-week sessions starting on July 2nd and running through August 10th.
- Interviewing new counselors and rehiring previous counselors.
- Scheduling summer camp field trips.

OTHER TOWN BUSINESS:

• Town Clerk Moody announced she has marked, large contractor bags in her office for residents to pick up if they wish to clean up along the roads in town. These contractor bags can be taken to the transfer station at no charge until April 30th.

<u>Motion to adjourn:</u> There being no further discussion Councilman LaFera made the motion to adjourn the meeting, seconded by Councilman Stewart; 4-0 Aye, 1 absent; motion carried. The meeting adjourned at 7:55pm.
