

Town Board Regular Meeting Tuesday, October 30, 2018 This regular meeting was held at the Rondout Municipal Center and began at 7:00pm

Supervisor Parete called the meeting to order at 7:02pm and Councilman LaFera lead the Pledge of Allegiance.

<u>RONDOUT VALLEY SUPERINTENDENT, DR. JOE MORGAN PRESENTS RVCSD CAPITAL</u> <u>PROJECT INFORMATION:</u>

- Dr. Morgan presented RVCSD Capital Project Information which addresses:
 - Health and safety
 - Energy efficiency
 - Long term financial stability
 - Instructional needs of the whole child
 - The capital project would include:
 - Roof and parking lot replacements
 - Old inefficient boilers
 - New LED lighting
 - Proposed athletic track and field improvements
- Capital project proposal
 - \circ \$61,800,000 \$2,000,000 (cash) = \$59,000,000
 - State aid will cover over 55% of the cost
 - Local share will be approximately: Tax Rate impact = average of \$1/03 per \$1,000 of assessed value over 15 years
 - \$100,000 Home = \$103
 - \$200,000 Home = \$206
- A few questions were asked to Dr. Morgan:
 - Maggie Colan, resident, asked if the auditorium would be ADA compliant?
 - Councilman Stewart asked if they had considered using solar panels while repairing the roof?

2019 FINAL BUDGET PUBLIC HEARING; GENERAL, HIGHWAY AND SPECIAL DISTRICTS:

- At 7:35pm a motion was made by Councilman Sweeney, seconded by Councilman Borzumato to open the public hearing on the 2019 budget for General, Highway and Special Districts. 5-0 Aye, motion carried.
- Jacob Sherman, resident, questioned what 'Budget-B', line item A1340.4 is? Town Accountant, Brian Pickard responded that was the line he is paid out of. Mr. Sherman questioned why that had increased. Supervisor Parete and Mr. Pickard, both, explained that in the past the Supervisor had contributed more to the budget process, with it being Supervisor Parete's first year doing the budget, Mr. Pickard did more work on the 2019 budget.
- Mr. Sherman questioned why the Town Clerk/Records Management line stated \$96,000? Mr. Pickard explained that the code items with a .1 are the salaries of the entire department, not just the Town Clerk.
- Mr. Sherman questioned the Attorney line and why that had increased?
- Mr. Sherman questioned the street lights budget line?
- Mr. Sherman questioned the Historian/ECC/HPC line? Supervisor Parete explained this was a combination of the Historian, the Environment Conservation Commission and the Historic Preservation Commission.
- Mr. Sherman pointed out and questioned why did Supervisor Parete decrease his salary? Supervisor Parete went on to explain he reviewed the supervisor's salary for the surrounding areas and he felt that was a fair salary. He also pointed out that by decreasing his salary it would help giving raises to all of the staff.
- Casey Kurti, resident objects to the supervisor taking a pay cut as it may impact the salaries of future supervisors.
- Supervisor Parete discussed the wage increases for the town employees. Employees earning less than \$20.00 an hour will get a 50-cent raise, plus 4%. Employees earning more than \$20.00 an hour will get a 4% raise.
- At 7:55pm there being no more comments or questions on the 2019 budget for General, Highway and Special Districts Councilman LaFera made a motion, seconded by Councilman Borzumato to close the public hearing on the 2019 budget. 5-0 Aye, motion carried.

2019 FINAL BUDGET PUBLIC HEARING; HIGH FALLS WATER DISTRICT:

- At 7:56pm a motion was made by Councilman Sweeney, seconded by Councilman Borzumato to open the public hearing on the 2019 budget for High Falls Water District. 5-0 Aye, motion carried.
- At 7:57pm there being no more comments or questions on the 2019 budget 2019 budget for High Falls Water District LaFera made a motion, seconded by Councilman Borzumato to close the public hearing on the 2019 budget. 5-0 Aye, motion carried.

PUBLIC COMMENTS:

Laurel Sweeney – Resident, thanked all the staff for their hard work on the creation of the new website and commented on how easy it was to find information. Mrs. Sweeney also took this opportunity to read a letter she recently wrote to the Blue Stone Press (published in the October 5, 2018 edition) in support of a question that will be on the upcoming ballot on election day. This ballot question is to determine whether to change the Ulster County Charter to allow creation of an independent Redistricting Commission.
