

Town Board Regular Meeting Tuesday, December 4, 2018 This regular meeting was held at the Rondout Municipal Center and began at 7:01pm

Supervisor Parete called the meeting to order at 7:02pm and Councilman LaFera lead the Pledge of Allegiance.

Supervisor Parete asked for a moment of silence in memory of George W. Bush.

### **PUBLIC COMMENTS:**

<u>Susan Sprachman</u> – Resident who has received and read the proposed report on event spaces. No one has stood up and supported the special events, so why are we spending so much time on this? If no one wants this why has it become expanded? Let's go back to the drawing board.

<u>Stuart Lee</u> – Resident who supports what Susan Sprachman commented on. If there were only going to be 2 to 3 events a year, that would be acceptable.

<u>Barry Spielberg</u> – Resident who agrees with both Susan Sprachman and Stuart Lee. What does 'Celebratory Events' mean? What is the scope and the definition? Very concerned. What is the definition of 'agricultural district'? As we move forward specifics do matter.

<u>Laura Wilensky</u> – Resident who feels the town needs to define noise regulations. Disturbed that the town is pushing this.

<u>Bruce Golden</u> – Resident who moved here fifty years ago. Residential area should remain residential.

<u>Bobbi Esmark</u> – Resident who feels we should have an information session with Will Husta. Where are the changes coming from and why? Two weeks ago, we spoke about setting a public hearing for 12/18. If we all want to be transparent and share, why don't we postpone the hearing until January or February? What is the rush?

<u>Joseph Giardullo</u> – Resident who questioned why the website was lacking updated PZC meeting minutes. Where are they? What is a celebratory event?

<u>Celia Seupel</u> – Resident who likes events. Not all events are weddings. Events help people who have land and it helps pay for taxes. If having a wedding with a band, not in a tent, it should be in a sound proof building. Main objection is the noise. There should be a noise ordinance. Events bring business to the town, helps economy.

**Deborah Gordon Brown** – Resident who said that the Warwick township has been asked to decrease the

amount of events they have. We need transparency. There should be no public hearing on 12/18.

<u>Danylo Mykula</u> – Resident who feels that if this law does pass, they should have to register.

<u>Stephanie Renza</u> – Resident who would like to see an economic impact study. Where is it? Real Estate prices will go down with the passing of an event space law. What will policing cost?

<u>Rebecca Callid</u> – Resident who questioned what is a residential district? What is an agricultural district? *Supervisor Parete pointed out that the County makes those definitions.* 

<u>Janet Krieger</u> – New York state offers farms to have events related to their what they are producing from their farms.

<u>Jacob Sherman</u> – Resident who stated agricultural district should be used to promote farming. New Paltz has a large agriculture area and they do not allow events. If this law passes, we would be allowing more then the state allows.

<u>Tom Herman</u> – Resident who questioned shouldn't we have a noise ordinance if we allow this? *Supervisor Parete commented these are very hard to maintain and enforce. Councilman Sweeney stated there are a lot of things that need to be looked at. Supervisor Parete pointed out that events have been taking place for 50 years, there have been no restrictions and now we are trying to restrict them. Councilman Sweeney said that all events will be subject to Special Use Permits and will have to follow all regulations.* 

Having a noise ordinance, even if flawed, is better than not having a noise ordinance.

<u>Chris (last name not given)</u> – Resident who asked for the names of places where these events took place? Supervisor Parete responded with Mohonk Mountain House and Preserve, New Beginnings, Shadowlawn and Mary Macnamara's.

<u>Eddie Croswell</u> – Resident who has lived here his whole life. Has the town given any consideration to properties that border the agricultural district and business districts? Will there be provisions if they are allowed to do these events? Real farms and farmers don't have to host events, they make their living doing what they do best, farming.

**Eric Krieger** – Resident who questioned the definition of celebratory events, which was also asked at the 11/20/18 meeting. Supervisor Parete and Councilman Sweeney both stated that the term 'celebratory events' had been removed from the document.

<u>Mickey Schaffner</u> – If the town has an ordinance, can the state override us? *Councilman Sweeney says yes, in agricultural districts. But the town can put more restrictive regulations on these rules.* 

### RESOLUTION #90-2018; SHARED SERVICES WITH THE TOWN OF ROSENDALE FOR SAFETY OFFICERS

The following Resolution was offered by Councilman Stewart seconded by Councilman LaFera:

**WHEREAS**, the Town of Marbletown has an opportunity to share services with the Town of Rosendale for the positions of Safety Officers; and

**WHEREAS,** the Town of Rosendale will provide Safety Officers to be paid by the Town of Rosendale; and **WHEREAS,** the Safety Officers will be paid the following salary:

Dorene Whitaker - \$ 5,202 per year

Michael Williams - \$ 1,768 per year, and

**WHEREAS**, the Town of Marbletown will cover one half of the salaries, taxes, bookkeeping and payroll related costs and reimburse the Town of Rosendale for one half of office materials and supplies, and

**WHEREAS**, the Town of Marbletown will budget up to \$300 for safety officer to be called to emergencies and attend quarterly meetings, and

WHEREAS, Bookkeeping & Payroll is estimated to cost around Five Hundred dollars (\$510) per year, and

**NOW, THEREFORE, BE IT RESOLVED,** the Town Marbletown shall reimburse the Town of Rosendale for Shared Safety Officer Services as stated above from January 1, 2019 - December 31, 2019; and

**BE IT FURTHER RESOLVED** that this resolution shall become effective upon its approval by both the Town Board of Rosendale and the Town Board of Marbletown.

### RESOLUTION # 91-2018; HIGH FALLS WATER DISTRICT EMPLOYEES SALARIES

The following Resolution was offered by Councilman Sweeney seconded by Councilman Borzumato: **WHEREAS**, the Towns of Rosendale and Marbletown jointly operate the High Falls Water District; and **WHEREAS**, it is necessary to set forth and agree to matters relating to the employment of those individuals who will perform work on behalf of the High Falls Water District, and to establish the funding for the work they perform, it is hereby

### **RESOLVED** as follows:

- 1. The High Falls Water District shall reimburse the Town of Rosendale a sum equal to Thirty-three and a third (33.3%) of all payroll expenses and benefits for the Town of Rosendale Employees who maintain and operate the Rosendale Water District, the Rosendale Sewer District and the High Falls Water District in the positions of Water & Sewer District Superintendent, Water and Sewer Operator and Water Sewer Trainees, who shall be an employees of the Town of Rosendale Water and Sewer Districts.
- 2. The Town of Marbletown shall directly pay the High Falls Water District Clerk for five hours per week at an hourly rate of Sixteen and 38/100 Dollars (\$16.38) per hour plus any employee benefits for those hours and shall be reimbursed for same by the High Falls Water District.
- 3. The High Falls Water District shall reimburse the Town of Rosendale the sum of Three Thousand Five Hundred Seventy Dollars and 00/100 Dollars (\$3,570) for payroll and bookkeeping and shall reimburse the Town of Marbletown Six Thousand Four Hundred Ninety-Four and 00/100 Dollars (\$6,494.00) for bookkeeping expenses.

This Resolution shall become effective upon its passage by both the Town Board of Rosendale and the Town Board of Marbletown and be effective January 1, 2019 to December 31, 2019.

**WHEREAS**, the Town of Marbletown will reimburse the Dog Warden and Deputy Dog Warden \$ .55 per mile for use; and

WHEREAS, the Town of Marbletown is responsible for a kennel and dog care; and

**NOW, THEREFORE, BE IT RESOLVED** the Town of Marbletown appoints Jill Shufeldt Dog Warden and Kevin Hindmann Deputy Dog Warden effective January 1, 2019 to December 31, 2019.

### RESOLUTION #93-2018; HEALTH INSURANCE BENEFITS FOR RONDOUT MUNICIPAL CENTER BUILDING MANAGER

The following Resolution was offered by Councilman Borzumato seconded by Supervisor Parete:

WHEREAS, the Town of Marbletown and the Town of Rosendale are parties to an Inter-Municipal Agreement dated December 9, 2015, which agreement sets forth the cooperative arrangement under which the Towns shall use, maintain and operate the Rondout Municipal Center; and

WHEREAS, Item 6 of said agreement discusses the position of Building Manager and the Towns respective contributions toward the salary and benefits for said position; and

WHEREAS, Steven Christiana is currently serving in the position of Building Manager and is an employee of the Town of Rosendale in accordance with applicable provisions of the Inter-Municipal Agreement; and

**WHEREAS**, the Town of Marbletown and the Town of Rosendale have determined to offer health insurance to the incumbent Building Manager, Steven Christiana, in accordance with certain terms and conditions.

NOW, THEREFORE, BE IT RESOLVED, that so long as the incumbent Building Manager, Steven Christiana, continues to work in that capacity for at least twenty-nine (29) hours per week, as well as for the Town of Marbletown as Fire Marshal for thirteen and one half (13.5) hours per week, the Town of Rosendale shall offer Mr. Christiana single health insurance coverage under the Town of Rosendale's plan, with Mr. Christiana contributing twenty-five percent (25%) toward the applicable health insurance premium effective January 1, 2019 through December 31, 2019; and

**BE IT FURTHER RESOLVED,** that the cost allocation of Mr. Christiana's health insurance shall be seventy percent (70%) for the Town of Marbletown and thirty percent (30%) for the Town of Rosendale, payable as mutually agreed by the two Towns; and

**BE IT FURTHER RESOLVED,** that should Steven Christiana fail to continue to work at least twenty-nine (29) hours per week as Building Manager and/or fail to continue to work at least thirteen and one-half (13.5) hours per week for the Town of Marbletown as Fire Marshal, that the Town of Rosendale may discontinue offering individual health insurance to Steven Christiana and offer him coverage pursuant to COBRA in the alternative; and

**BE IT FURTHER RESOLVED,** that this Resolution shall become effective if approved by the Town Boards of the Town of Rosendale and the Town of Marbletown and shall remain in effect unless and until modified by future action of the Town Boards of the Town of Rosendale and the Town of Marbletown.

# RESOLUTION #97-2018: SET PUBLIC HEARING FOR PROPOSED LOCAL LAW NUMBER 3 OF 2018, TO AMEND THE DOG CONTROL LAW

**WHEREAS**, the Town Board of the Town of Marbletown voted October 30, 2018 to enter into a contract with the Ulster County SPCA for the care and boarding of canines effective November 1, 2018; and,

**WHEREAS**, the Town Board desires to have seized dogs held for a redemption period of 7 days, and **WHEREAS**, an amendment to Chapter 103-6 of the Town Of Marbletown Code is necessary,

- (1) Not amended
- (2) Every dog so seized shall be held for a redemption period of <del>10.</del>7 days from the date of seizure, or in the event that the owner of such dog can be identified and notified of such seizure within such period as required by §117(6) of the Agriculture and Markets Law, <del>10.</del>7 days from the date of such notification, whichever occurs last. This provision is meant to supersede and supplant the <del>shorter</del> redemption periods set forth in §117(6) of the Agriculture and Markets Law
