

Town Board Regular Meeting Tuesday, March 19, 2019 This regular meeting was held at the Rondout Municipal Center and began at 7:00pm

Supervisor Parete called the meeting to order at 7:05 pm and lead the Pledge of Allegiance.

PUBLIC COMMENTS (GENERAL):

Jeff Domanski: Jeff Domanski came to speak about Joule Assets, Inc. which sought approval of a community choice energy aggregation ("Community Choice") program through the Public Service Commission of the State of New York, which would allow local governments to participate in a Joule program to procure energy supply from an Energy Services Company for the residents of participating municipalities. The Joule program is intended to include residential and small non-residential customers, and to permit the aggregation of electric purchases by the communities which elect to participate. The Town of Marbletown has adopted a Local Law to participate in the Joule Community Choice Program to aggregate consumers located within the Municipality and to negotiate competitive rates for the supply of electricity for such consumers. Mr. Domanski said there will be information sessions and there will be a mailing going out to the Community with an opt out option. Currently, the City of Beacon, the town of Fishkill, Cold Spring and now Marbletown are all participating. Maggie Colan: Resident who stated March is National Kidney month. There are two kinds of donors, deceased and living donor. Please spread the word and become a donor, it could save someone's life. **Daisy Foote:** Resident who came into discuss the Community Center and Bobbi Esmark's tai chi class. Ms. Esmark is now holding her classes as MOMA and it is not optimal for the class. The Community Center was perfect for the class. Ms. Foote was curious about the requirements to have the class back at the Community Center. Would there be a way for Ms. Esmark to achieve non-profit status? Supervisor Parete stated that when

Ms. Foote said in the future it would be nice to keep open lines of communications and the whole process could have been more thoughtful.

RESOLUTION #25-2019: AUTHORIZING PURCHASE OF PARK BENCHES, SPEED SIGNS AND POLE ATTACHMENTS FOR HIGH FALLS

The following Resolution was offered by Councilman LaFera seconded by Councilman Borzumato to wit: WHEREAS, the Hamlet of High Falls in the Town of Marbletown was incorporated in 1669, and WHEREAS, it is fitting to recognize High Falls on this 350-year milestone, applaud its distinguished history and mark this anniversary with a series of celebrations, and

WHEREAS, the Town Board of the Town of Marbletown wishes to support High Falls community groups preparing for celebrations by purchasing solar speed signs, park benches and pole mounts, and

WHEREAS: the identified improvements include 1) two radar activated speed signs alerting motorists on NYS Route 213 to reduce speed to 30 MPH commencing at the Easterly and Westerly borders of High Falls; and, 2) benches to be located at two bus stops in the hamlet, replacing two that are severely deteriorated, and one that will be a first installation; and 3) ten banner brackets to be installed on utility poles located in central High Falls for the purpose of mounting banners identifying the Hamlet as a National Registered Historic District, and announcing seasonal and special events; and

WHEREAS, the cost of two park benches is \$3500, two speed signs are \$9500, and ten pole mounts are \$800, and

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Marbletown authorizes the Supervisor to purchase two park benches, two speed signs, and ten pole mounts for a cost not to exceed \$13,800.

RESOLUTION #27-2019; TO AUTHORIZE EXECUTION OF MEMORANDUM OF UNDERSTANDING WITH JOULE ASSETS, INC. REGARDING COMMUNITY CHOICE AGGREGATION PROGRAM

The following Resolution was offered by Councilman Stewart seconded by Councilman Borzumato to wit: **WHEREAS**, the Town Board previously entered into a Municipal Energy Services Agreement with Joule Assets, Inc. ("Joule") with respect to the Community Choice Aggregation program ("CCA Program") which would allow the Town of Marbletown (the "Town") to participate in a program to procure energy supply for residents within the Town from energy services companies for the residents of the Town, with Joule Assets, Inc. as Program Manager; and

WHEREAS, to launch the CCA Program, the Town and Joule seek to obtain competitive electricity supply bids from electricity suppliers that will lead to the execution of an Electricity Supply Agreement (the "Supply Agreement") with a bidder selected in accordance with the terms and conditions of a Memorandum of Understanding between the Town and Joule (the "MOU"); and

WHEREAS, the Town and Joule are seeking to enter into the MOU to: (i) confirm that Joule will serve as Program Administrator for the CCA Program in relation to the Supply Agreement; and (ii) obtain the parties'

agreement that each will execute a Supply Agreement with a selected bidder, subject to the terms and conditions in the MOU.

NOW THEREFORE, BE IT RESOLVED, that, the Supervisor of the Town of Marbletown is authorized to execute the attached MOU and take other actions necessary in furtherance of the Town's participation in the CCA Program; and

BE IT FURTHER RESOLVED, that the Supervisor is authorized to execute an Electricity Supply Agreement, in the form attached as Exhibit "1" to the Memorandum of Understanding, subject to further review and revision by the Town Board, which Electricity Supply Agreement authorizes Joule to accept bids for energy services for the Town so long as the minimum requirements set forth in the MOU and Electricity Supply Agreement are satisfied.
