<u>Caroline Berninger:</u> Resident who brought up the discussion of a streetlight at the intersection of Schoonmaker Lane and Rt. 209. Someone has complained that it is too bright, and someone has complained that it is not bright enough. This is not a well lite intersection. The light possibly needs to be re-oriented. Tom Konrad, ECC Chairman, suggested asking DOT to put up guardrails with reflectors which might help that area. Supervisor Parete said he would call the DOT to inquire about the guardrails.

#### **SOLAR LAW:**

• Tom Konrad, ECC Chairman and Tracey Kellogg, Town Attorney reviewed the town solar law, which was passed in August 2017. It has been requested that the law be amended to include the B-1 district. Michael Tumminia, owner of the RidgeWell Center on Main Street, has requested a variance to install large scale solar at his new business, but he is in B-1 and that is not allowed. Mr. Konrad explained that this was an oversight, back in 2017. He would like it to be allowed everywhere and then you would need to get a special use permit. Mr. Konrad also stated that they separated the definition of power generation plant to fossil and non-fossil and removed fossil generation as a permitted use. These changes were recommended by the ECC and will now be forwarded to the Planning Board for their review and recommendations.
