RESOLUTION #52-2019; GRADY PARK LEASE

The following Resolution was offered by Councilman Stewart, seconded by Councilman Sweeney:

WHEREAS, the Town is interested in expanding areas available for use and enjoyment by the residents of the Town of Marbletown, and

WHEREAS, the D&H Canal Historical Society and Museum ("the D&H") is interested in making available property in the Town of Marbletown, in the Hamlet of High Falls, and

WHEREAS, the subject of this resolution is limited to four parcels of landowner by the D&H located within the Hamlet of High Falls; and

WHEREAS, those parcels are identified as parcels 70.2.4-1, 70.2.4-2, 70.2.4-3, 70.2.4-4, together, ("That CertainTract"); and

WHEREAS, that Certain Tract contains ruins of Lock 17 and Lock 18, a historically protected ruin of the Delaware and Hudson Canal, and subject to all government laws and restrictions thereon; and

WHEREAS, the execution of the Option and Ground Lease Agreement for the Property is subject to a permissive referendum pursuant to Section 64, Subdivision 2 of the New York State Town Law;

WHEREAS, the Town of Marbletown is prepared to undertake such implementation for the benefit and enjoyment of residents, visitors, and friends of High Falls;

WHEREAS, this resolution is subject to permissive referendum pursuant to subdivision 4 of section 6-c of the General Municipal Law.

THEREFORE, **BE IT RESOLVED**, that the Town of Marbletown Town Board authorizes the Town Supervisor to sign the attached lease to enter 99-year lease (the "Lease") between the D&H (Lessor) and the Town of Marbletown (lessee), and be it further

RESOLVED, that this Resolution is adopted subject to a permissive referendum and that the Town Clerk is directed to publish and post the notice of this Resolution in accordance with Article 7 of the Town Law within ten (10) days; and it is further

RESOLVED, that upon the expiration of the permissive referendum period, the Town Supervisor is authorized to execute all documents required to complete the Option and Ground Lease Agreement subject to review and approval of the Town Attorney for the Town as to form and content.

RESOLUTION #53-2019; RESOLUTION NEW YORK STATE ENERGY RESEARCH AND DEVELOPMENT AUTHORITY (NYSERDA")

WHEREAS, the Town of Marbletown was awarded a \$50,000 NYSERDA a grant for the Marbletown Community Center (MCC) which needs new energy systems, envelope improvements and insulation upgrades, and WHEREAS, through the "Energy Upgrades at Marbletown Community Center" (EUMCC), project, the Town of Marbletown will use Clean Energy's Community (CEC) funding to implement measures identified in the energy audit, and

WHEREAS, the Town Board agrees to match the \$50,000.00 grant, and

THEREFORE, BE IT RESOLVED, the Town Board of the Town of Marbletown authorizes the Supervisor to sign the contract at a not to exceed cost of \$100,000.00 including NYSERDA Grant monies.

OTHER TOWN BUSINESS:

- Supervisor Parete Announced that UCRRA 5-year contract with Seneca Meadows expires in December. The UCCRA went out to bid and got their rates back with a 5% increase. As of now we pay \$103.00 a ton. Rates will possibly go up to around \$105.00-\$106.00 a ton. This is a 5-year locked contract.
- Supervisor Parete talked about the creek walk. The state gave us a right of easement for the past year. The state sent the town a notice in the mail that they are setting up a closing for July 30th in Poughkeepsie. The town will then own that walkway.
- The town received \$100,000.00 sidewalk grant from Senator Amedore. Going to put the sidewalk in in front of the Co-op. Supervisor Parete says installation should start this fall 2019.
