

Town Board Regular Meeting Tuesday, October 15, 2019 This regular meeting was held at the Rondout Municipal Center and began at 7:00pm

Supervisor Parete called the meeting to order at 7:02pm and Councilman Stewart lead the Pledge of Allegiance.

PUBLIC HEARING - PROPOSED LOCAL LAW #4-2019 'SHORT TERM RENTAL'

- At 7:04 PM Councilman Stewart made a motion to open the Public Hearing on proposed Local Law # 4-2019 'Short Term Rental'.
- Town Clerk Moody stated that the public hearing was legally noticed in the Daily Freeman on Sunday, Oct. 6th. The legal notice was also posted on the town website, posted on the Community Bulletin board outside of the Town Clerk's office and sent out to surrounding town clerk's offices.

PUBLIC COMMENTS:

- Ray & Vanessa Vargas, Home Sweet Hudson Full-service company that will manage the responsibilities of Airbnb's if hosts are not onsite. Their website is homesweethudson.com.
- Tracey Dewart Resident who read a statement and stated she has a short-term rental on her property. She feels regulations should be set in place especially about setting a cap on the number of guests. She wanted to know who was on the committee to write the law? The supervisor has a rental property. She mentioned that former Supervisor Thomas Jackson had a conflict of interest and he stepped down because of it.
- Jacob Sherman Resident who read a statement and commented that there were grammar and spelling errors on the copy of the law. He feels there have been no enforcement provisions or no fines/violations. What about a noise law, there is no noise law in town? He feels we should use the Rhinebeck law as guidance as it is very strict. Short term rentals happened fast but special events have gone away.
- Susan Sprachman Resident who read a statement in support of the short-term rentals and applauds the effort but has concerns about the law. We should have a public forum so people can discuss. If fees are set where will the fee's go? Rhinebeck limits the number of people in a short-term rental to 6. What about adults vs. children? What about complaints and violations? She would also like to see a proximity limitation. In Woodstock people have to be made aware if houses are short term rentals.
- Bill Terpening Resident who read a statement and said that the law is unfriendly to our residents. He compared out law to Rhinebeck where there must be a primary resident on the property. Our law does not regulate how close they can be or how many lots. Marbletown can have 10 people vs. 6 in

- Rhinebeck. What about a noise ordinance? He would like all town board members to disclose if they have or have had any short-term rentals.
- Janet Condon-Krieger Resident who asked why is there such a rush on this law? Went to a forum at New Paltz about this topic. Feels too many short-term rentals will push out the younger generation because there will be no housing.
- Doug Adams Resident who read a statement and who feels this law is a two-edged sword. He feels we need to guarantee the health and safety of people and property. He read statistics about room tax, bed tax and city and state tax in NYC. He also said that statistically, seniors have the most Air B-n-B's. On a final note he added that two of the town board members are real estate agents which could be a conflict.
- Stacy Sindt Resident who has been sitting on the PZC and pointed out that every point that has been brought up has been discussed during the meetings and the planning of this law. So, why didn't these residents bring their concerns to the meetings, where everyone is welcome. The goal is to limit and to make safe.
- Eric Krieger Resident who feels that safety is an issue.
- Daisy Foote Resident who feels the law is problematic and vague. She pointed out that Woodstock's law was not set with specifics and they are now getting sued. She would like to see the town be involved and the go back to the committee.
- On advice of Attorney Kellogg Supervisor Parete held the public hearing open.

PUBLIC HEARING - PROPOSED LOCAL LAW #5-2019 'PARKING REGULATION LAW

- Councilman Stewart made a motion to open the Public Hearing on proposed Local Law # 5-2019 'Parking Regulation Law'.
- Town Clerk Moody stated that the public hearing was legally noticed in the Daily Freeman on Sunday, Oct. 6th. The legal notice was also posted on the town website, posted on the Community Bulletin board outside of the Town Clerk's office and sent out to surrounding town clerk's offices.

PUBLIC COMMENTS:

- Jack Boden Resident who feels that the all parking regulations should be enforced throughout all of Marbletown and respectfully requests safety by the falls and in the town.
- Supervisor Parete held the public hearing open.

PUBLIC COMMENTS:

<u>Jack Boden:</u> Resident who read a letter from fellow resident, Jeanne Hunt regarding funding in the 2020 town budget for the Marbletown First Aid Unit. She states that the MFA unit has had a decrease in skilled volunteer staff and had to cut their budget and future ambulance equipment fund to pay the \$14/hour to fill the volunteer loss. Results have proved funding works because the response rate increased from 60% to approx. 93%. More than 85% of the dispatches are in our town. This nonpolitical dedicated organization can only function well with staff and funding.

Rebecca Horner: Chair of the Marbletown First Aid Unit who submitted a letter and a copy of the MFA 2020 budget. (Copy is on file in the town clerk's office). They are formally requesting funding for 2020 in the amount of \$242,974. She also stated their volunteerism is declining across the country. Their response rate has gone from 75% to 93%. They really need town funding. On 10/22/19 there will be a public forum for all residents. **Chris Needen:** MFA Unit volunteer who has asked that the town please, increase the funding. It used to be \$40,000 a year and it has been decreased to \$20,000.

Robert King: MFA Unit volunteer who has asked for support for funding. MFA needs people with skills and that helps save lives. Please increase our funding.

Peter Lamerson: MFA Unit volunteer, trained to be a shift leader. Please increase the budget. He has asked that Supervisor Parete meet with other Supervisors to discuss increasing the funding and to make this a priority. Joe Vitti: MFA Unit volunteer for 12 years. He thanks the town board for listening. He had to call 911 once and it inspired him to join.

Carol Laurito: Resident who thanked the MFA Unit for assisting when she had an accident.

Bob Berry: Resident who moved from Brooklyn. His neighbor had an issue and MFA Unit came to help. Mr. Berry complimented the MFA Unit. When he retires he hopes to become a volunteer.

WHEREAS, those parcels are identified as parcels 70.2.4-1, 70.2.4-2, 70.2.4-3 and 70.2.4-4, together, ("That Certain Tract"); and

WHEREAS, that Certain Tract contains ruins of Lock 17 and Lock 18, a historically protected ruin of the Delaware and Hudson Canal, and subject to all government laws and restrictions thereon; and

THEREFORE, BE IT RESOLVED, that the Town of Marbletown Town Board authorizes the Town Supervisor to sign the attached contract with Poison Ivy Patrol for Phase 1 of Grady Park restoration at a cost of \$11,000.
