Supervisor Parete called the meeting to order at 7:01pm and Councilman Sweeney lead the Pledge of Allegiance.

NYSERDA; NY STRETCH ENERGY CODE; MARILYN DARE, SENIOR PROJECT MANAGER, ENERGY CODES:

- Tom Konrad, ECC Chairman introduced Marilyn Dare from New York State Energy Research and Development who gave the board, and the town, a presentation on the NY Stretch Energy Code, what the ECC has voted to ask the town to adopt.
- This would be a readily adoptable local energy code that is more efficient than NYS's base energy code. It would call for higher energy efficiency standards for new and renovated construction projects.
- Other communities already expressing interest in the NYStretch Albany, Bethlehem, Rochester, Lower Hudson Valley towns and cities, Towns on Long Island.
- The initiative should save energy and money, help the environment, boost the local economy improve community growth and increase property value.
- If Marbletown adopted the code the entire town would need to comply with the code.
- If Marbletown is interested we would need to review the resolution language and work with the building department.

RESOLUTION #99-2019; TO ADOPT LOCAL LAW NO. 4 OF 2019, ENTITLED A LOCAL LAW KNOWN AS "THE SHORT-TERM RENTAL LAW"

WHEREAS, a proposed local law entitled, "Short Term Rental Law" was presented to the Town Board on November 19, 2019; and

WHEREAS, the proposed law was referred to the Ulster County Planning Board pursuant to Section 239-m of the General Municipal Law, which responded on October 2, 2019, that the Town Board has considered the County comments; and

WHEREAS, a resolution was adopted by the Town Board of the Town of Marbletown on September 3, 2019, setting a public hearing to be held by said Town Board on October 15, 2019 at 7:00 p.m. at the Rondout Municipal Center, to hear all interested parties on the proposed local law; and

WHEREAS, notice of said public hearing was duly advertised in the Daily Freeman, the official newspaper of said Town, not less than ten days prior to the date of said public hearing; and

WHEREAS, said public hearing was duly held on October 15, 2019 at said time and place and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed local law, or any part thereof; and

WHEREAS, the proposed local law constitutes a Type I action for purposes of the State Environmental Quality Review Act; and

WHEREAS, the Town Board of the Town of has determined after review that the adoption of a Local Law known as the Short-Term Rental Law does not have a significant environmental impact; and

WHEREAS, The Town Board of the Town of Marbletown after review finds that it is in the public interest to enact this local law.

NOW THEREFORE BE IT RESOLVED, by the Town Board of the Town of Marbletown as follows:

- 1. The Town Board hereby adopts said Local Law No. 4 of 2019, entitled, "Short Term Rental Law".
